Significant Issues:

State Operations continues to be an active participant in the Anderson Complex Cooperators Team. The SEOC anticipates sending emergency managers up to the Anderson Complex with the Mobile Emergency Operations Center (MEOC) trailer today. The MEOC will be staffed for the remainder of the threat, to provide a reliable base of operations and communications platform. The SEOC continues daily contact with both the Denali and North Star Borough local emergency management personnel, ensuring lines of open communication for potential expanding evacuation and with the Department of Forestry and Fire Protection for logistics support and fire resources.
