Significant Issues:

Wrangell Landside Disaster:

State Individual Assistance application hotline and website is open for Wrangell and Prince of Wales Island residents at <https://www.ready.alaska.gov/Recovery/IA> or by phone 1(844) 445-7131. The deadline to apply for State Individual Assistance is January 27, 2024.

Tuluksak Power Outage:

SEOC received an update from the Remote Maintenance Worker (RMW) that the new generator has been installed. The city and water plant are back to normal running conditions.

Selawik Power Outage:

The SEOC, Northwest Arctic Borough and AKVOAD continue to work with the City of Selawik to support any unmet needs due to a power outage and freeze up.

Point Hope Power Outage:

SEOC is actively monitoring Point Hope’s response with community officials and the North Slope Borough.

Manokotak Power Outage:

SEOC is actively monitoring progress with community officials and mass care partners. AEA continues to support the community with generator contingency plans and technical assistance.

Savoonga Power Outage:

SEOC remains in contact with local officials and local damage assessment is ongoing for possible loss of food.

State of Alaska Department of Health (DOH)

The DOH stands ready to assist with all aspects of public health and, in the event of a public health

emergency, is supported by the SEOC and other state departments as required.

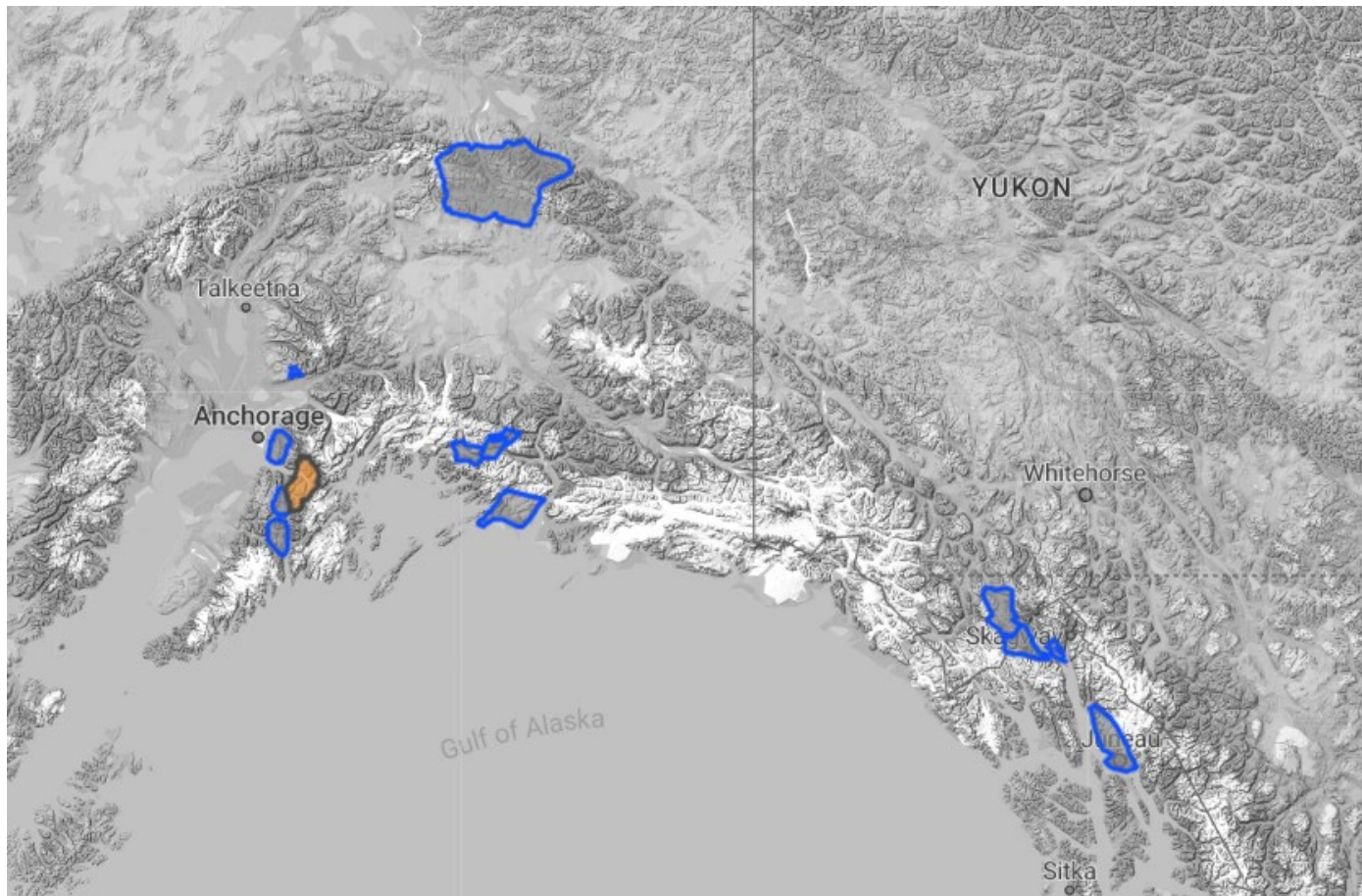

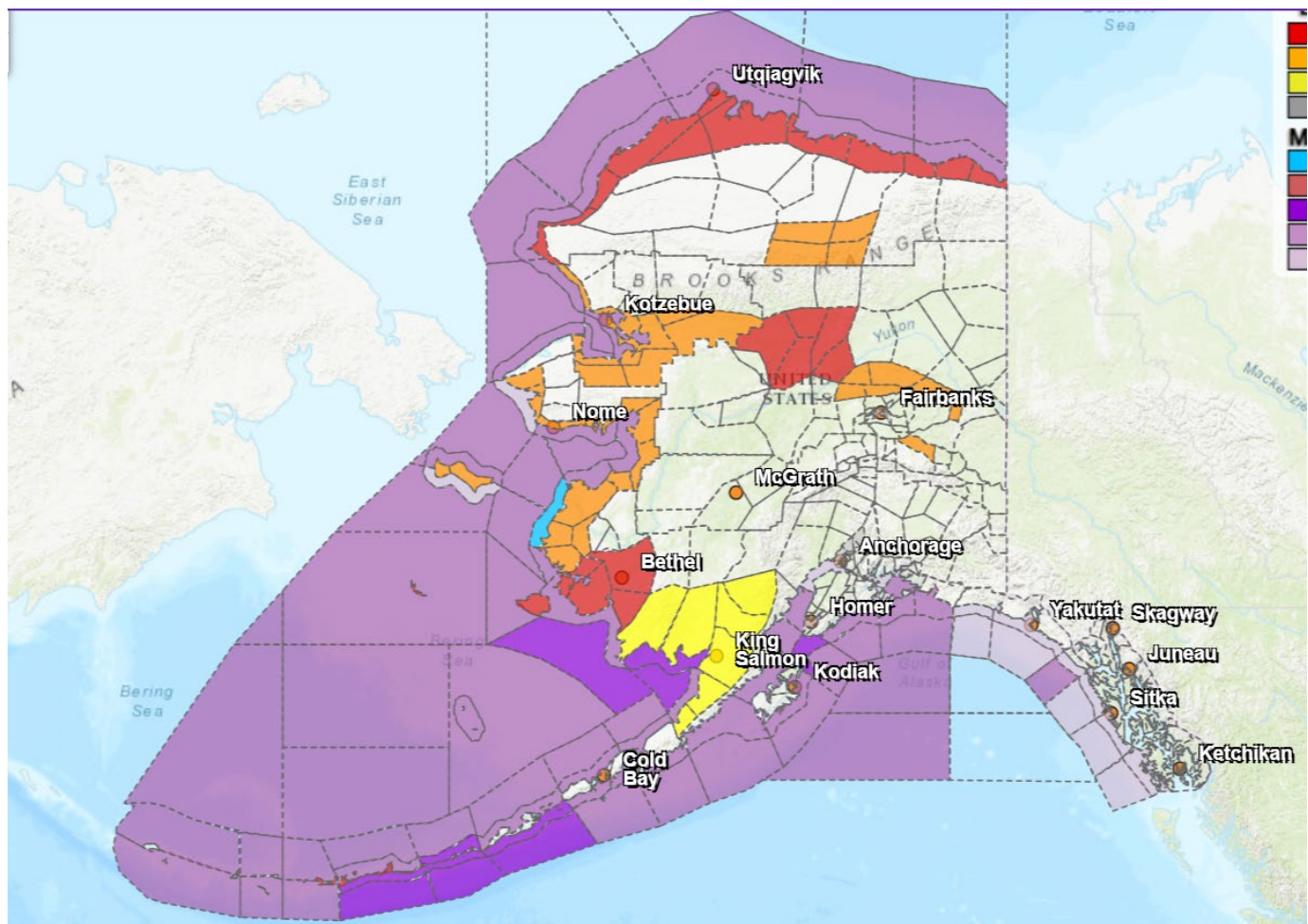
Avalanche Hazards:

- Central Brooks Range from midnight tonight until Friday at 3pm
- Bering Strait Coast until this afternoon at 3pm
- Yukon Delta Coast until Wednesday at 6am
- Northern Seward Peninsula from noon today until Wednesday at 6pm
- St. Lawrence Island until Thursday at 2pm
- Southern Seward Peninsula Coast; Eastern Norton Sound and Nulato Hills until Thursday at 3pm
- Kivalina and Red Dog Dock; Lower Kobuk Valley; Baldwin Peninsula; Upper Kobuk Valleys until Thursday at 6pm
