Significant Issues:

Chignik Bay – Avalanche and Power Outage

Last night the SEOC received an update that the power was restored throughout the community. SEOC will remain in close contact with community leaders, DOT&PF, and AEA in support of any further response and recovery deemed necessary.

Kotzebue – Frozen Water Lines

Yesterday, the SEOC deployed a staff member who arrived in the community last night in support of the continued coordination of response and recovery.



Avalanche Hazards:




Travel in avalanche terrain is not recommended. Avoid being on or beneath all steep slopes.
