**Significant Issues:**

Yesterday SEOC was notified of a building fire in Kivalina. SEOC contacted the community who state the fire impacted the bingo hall and city office building. SEOC also contacted NW Arctic Borough State fire marshal's office, state troopers, department of health, and DEC for situational awareness. There are no injuries ongoing evacuations, or requests for assistance for the SEOC. SEOC will continue to monitor the situation and support the community and borough as needed.

South Tongass Fire Station; The South Tongass Fire Chief in the Ketchikan Gateway Borough contacted SEOC last night reporting a fire at the Department's station that destroyed the station and all apparatus. The Department has received emergency loan of apparatus from an adject jurisdiction and the State and is considering options for funding station rebuilding and permanent apparatus replacement.

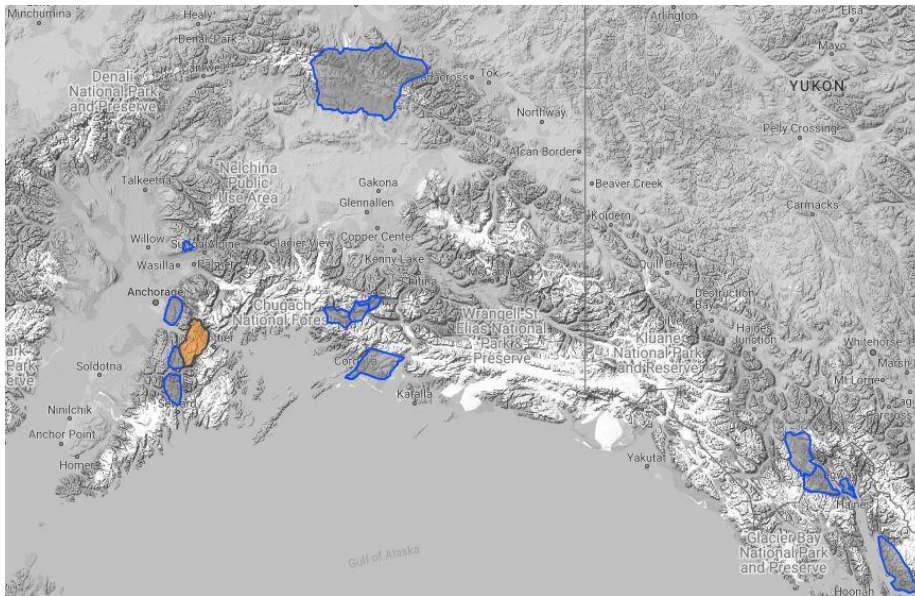

## Avalanche Hazard

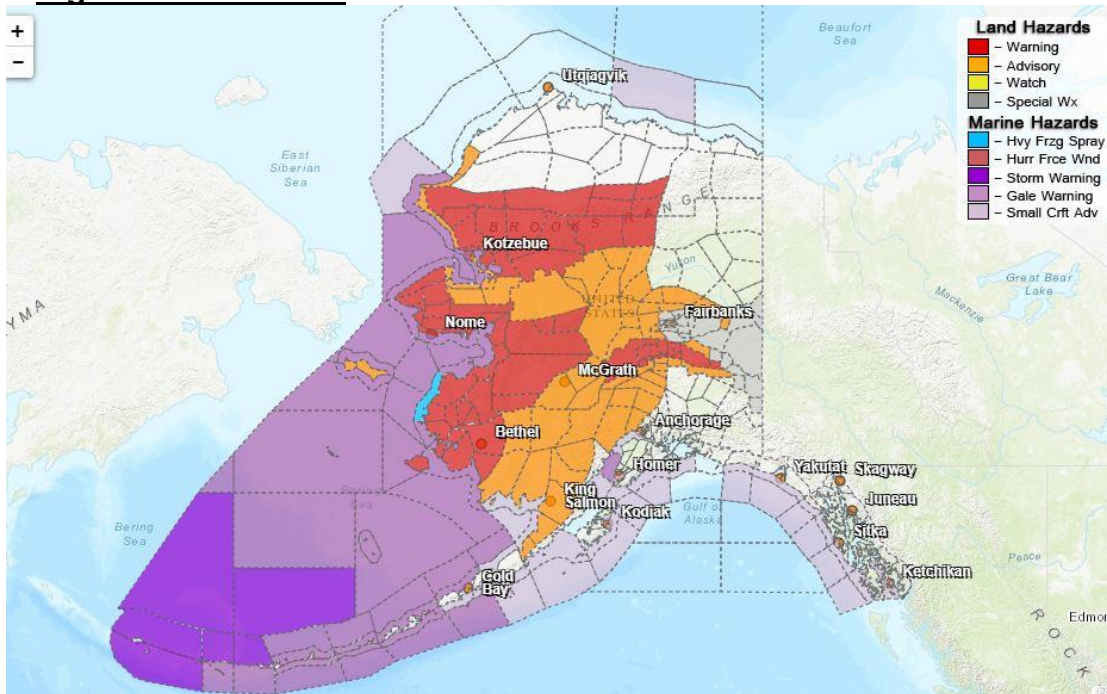


Travel in avalanche terrain is not recommended. Avoid being on or beneath all steep slopes.
