Significant Issues:

The SEOC has activated to level 2 to support annual Riverwatch operations that monitor ice breakup flooding along the Yukon River, Kuskokwim River, and major river systems in Alaska. SEOC will continue active operational coordination throughout the breakup season.

Little Diomedede Structure Failure:

The SEOC received a report that a home was tilting enough that it was causing concern of complete collapse and impact to two homes and the clinic below it. Subsequent calls indicated that there are homes with structural challenges and the SEOC is reviewing options to the community to help secure the homes and strengthen the structures.

Riverwatch:

Upper Yukon division team will deploy today, and the Kuskokwim River division team will deploy on Wednesday to begin the Riverwatch Program. The most current Spring Breakup Outlook is attached to this Situation Report.

Southeast Island REAA:

The U.S. Small Business Administration (SBA) has declared a Rural Disaster for the Southeast Island REAA in response to landslide that occurred in Wrangell and Prince of Wales Island last winter. The SBA press release is attached to this Situation Report.

The DOH stands ready to assist with all aspects of public health and, in the event of a public health emergency, is supported by the SEOC and other state departments as required.

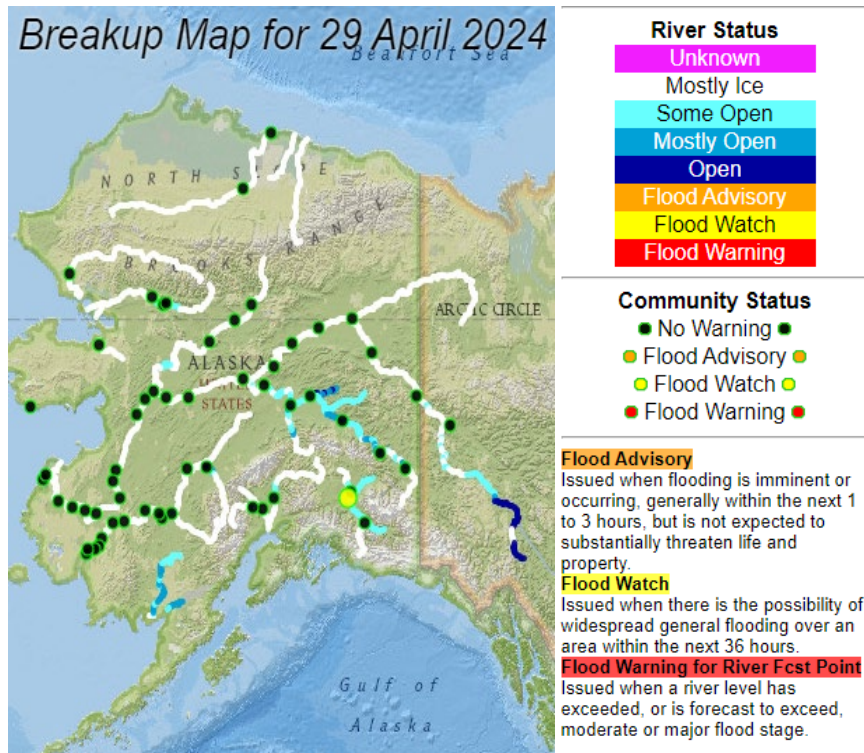
