# Resources for Alaskans Still Needing Help After the Earthquake

For Alaskans who were affected by the Nov. 30 earthquake, state, local and federal organizations are still available to provide guidance, counseling and resources to help you reach your long-term recovery goals.

These resources are available to individuals and households in the designated areas of **Municipality** of Anchorage, Kenai Peninsula Borough and Matanuska-Susitna Borough.

#### **State and Local Resources**

If you have a pending application for state individual assistance or have questions regarding a reconsideration, contact the Alaska Division of Homeland Security and Emergency Management Individual Assistance Program hotline at **855-445-7131**. To learn how to request reconsideration from the state, visit ready. Alaska.gov.

United Way Disaster Services offers a hotline for finding a variety of resources in your community, call **211** or **800-478-2221**; 8:30 a.m. to 5 p.m. Monday-Friday or visit <u>Alaska211.org.</u>

Staffed by volunteer attorneys, the helpline is open 6 p.m. to 8 p.m. Tuesdays and Thursdays, except holidays.

## **Federal Resources**

**FEMA** – Although the application deadline for federal disaster assistance has passed, help with an existing application or appeal is just a click or call away.

<u>DisasterAssistance.gov</u> offers a customized list of assistance that may be available to you. No login or personal information is required. Simply click Find Assistance. Residents can also call the helpline at **800-621-3362** (**FEMA**). Lines are open daily from 6 a.m. to 9 p.m.

If you already registered for federal disaster assistance, you can create an online account at <u>DisasterAssistance.gov</u> to view and update your information.
