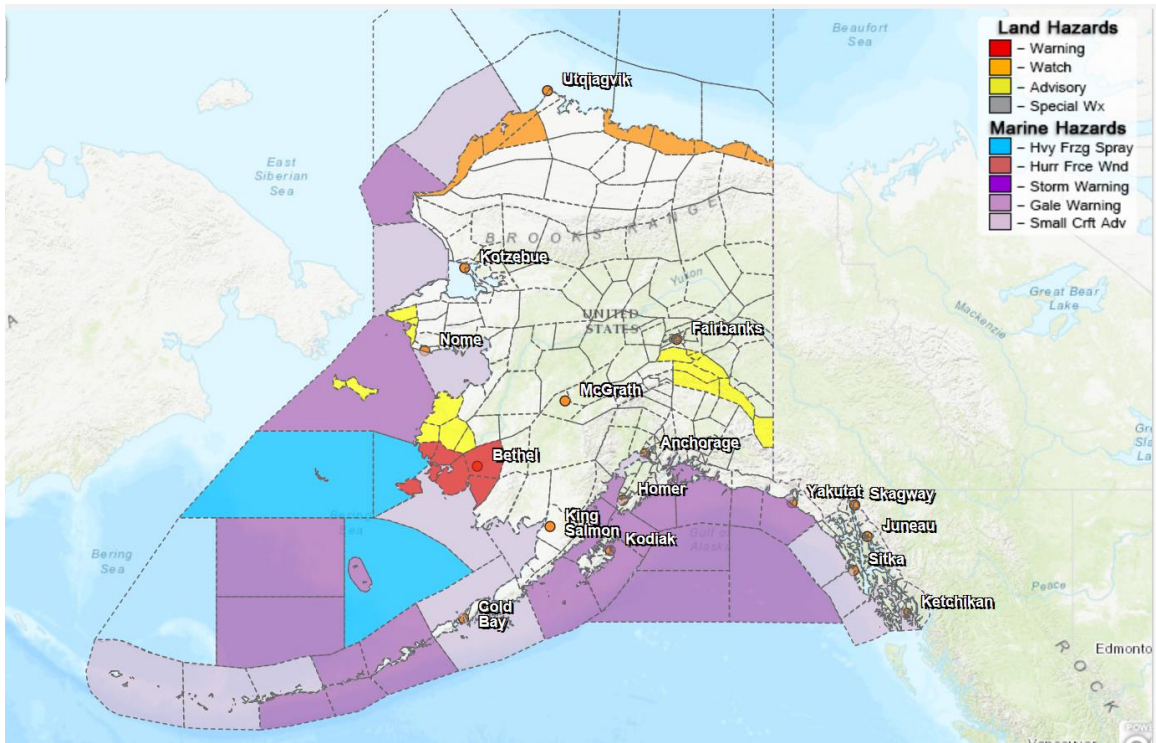
**Cook Inlet M7.1 Earthquake (FEMA Declaration 4413-DR)**

The SEOC remains activated to Level 3. This is the 110<sup>th</sup> day since the earthquake. FEMA command and general staff are still working out of the SEOC; a Joint Field Office (JFO) has not yet been set up. FEMA has 241 persons working in Alaska on this disaster. SBA has approved 474 home loans and 21 business loans totaling almost \$25 million. **DHS&EM staff are evaluating the results of a preliminary damage assessment performed Tuesday in Whittier**

There is a Blizzard Warning for the Kuskokwim Delta until 1PM AKDT this afternoon and a Winter Weather Advisory for the Yukon Delta, St. Lawrence Island and Bering Strait Coast until 6PM AKDT Friday. Additionally, there is a Wind Advisory for the Deltana and Tanana Flats in effect until noon AKDT today. A Winter Storm Watch is in effect for the Western Arctic Coast, Central & Eastern Beaufort Sea Coast from Friday afternoon through late Friday night.
