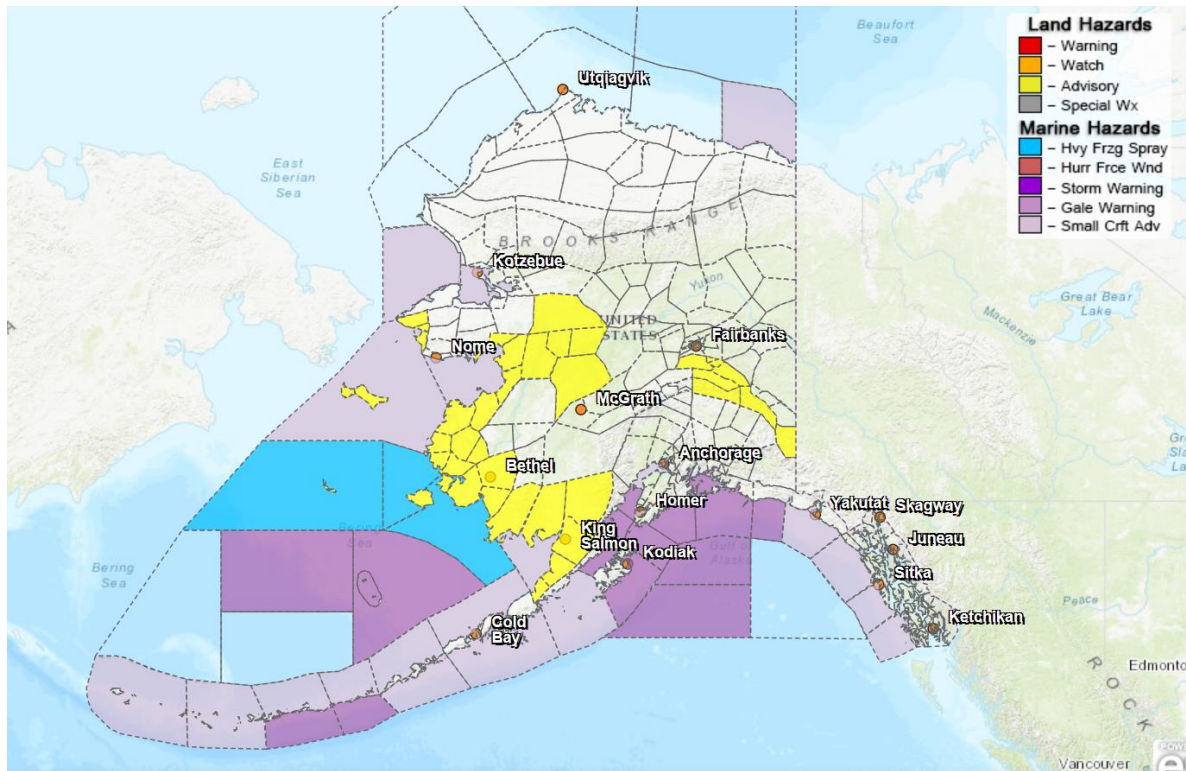
Cook Inlet Earthquake (FEMA Declaration 4413-DR)

The SEOC remains activated to Level 3. This is the 109th day since the earthquake. FEMA command and general staff are still working out of the SEOC; a Joint Field Office (JFO) has not yet been set up. FEMA has 241 persons working in Alaska on this disaster. To date, FEMA has dispensed \$6.9 million in Individual and Households Program funds and \$6.8 million in Housing Assistance funds. SBA has approved 474 home loans and 21 business loans just short of \$25 million. DHS&EM staff conducted a preliminary damage assessment in Whittier Tuesday, looking at possible earthquake damage to several harbor facilities and the breakwater.
