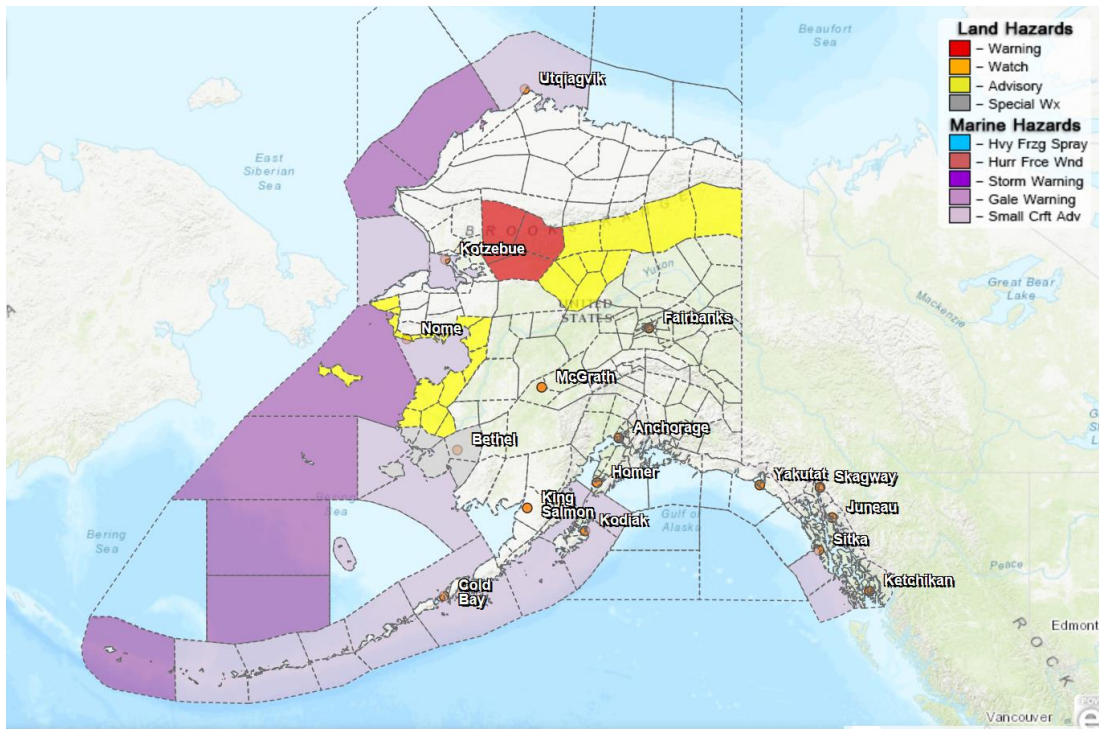
Cook Inlet M7.1 Earthquake (FEMA Declaration 4413-DR)

The SEOC has returned to Preparedness Level 1: Normal Operations. FEMA command and general staff are still working out of the SEOC; FEMA has 241 persons working in Alaska on this disaster. As of COB on Friday, 22 March, FEMA has dispensed almost \$7.25 million in Individual and Households Program funds and \$7.1 million in Housing Assistance funds. SBA has approved 626 home loans and 26 business loans.
