**Significant Issues:**

**Wildland Fires**

The SEOC continues to support wildland fire operations. State Public Assistance, Individual Assistance (IA), and Temporary Housing programs are activated pursuant to Governor’s State Disaster Declaration for the Matanuska Susitna Borough and Kenai Peninsula Borough. Volunteer, faith-based, and other Mass Care agencies are supporting survivors with emergency supplies and relief actions.

**Water Shortages**

The SEOC continues to assist communities within the Lake and Peninsula and Kenai Peninsula Boroughs, to recover from their shortage of fresh water. The Alaska Department of Environmental Conservation, regional tribal health organizations, and volunteer and faith-based organizations have furnishing the following communities with a temporary water supply:

- Chignik Lagoon
- Seldovia
- Nanwalek

As of last evening, Chignik Lake, Tatitlek, and Cordova have sufficiently recharged their water supply and are no longer reporting a shortage of potable water.

**2019 Fire Season**

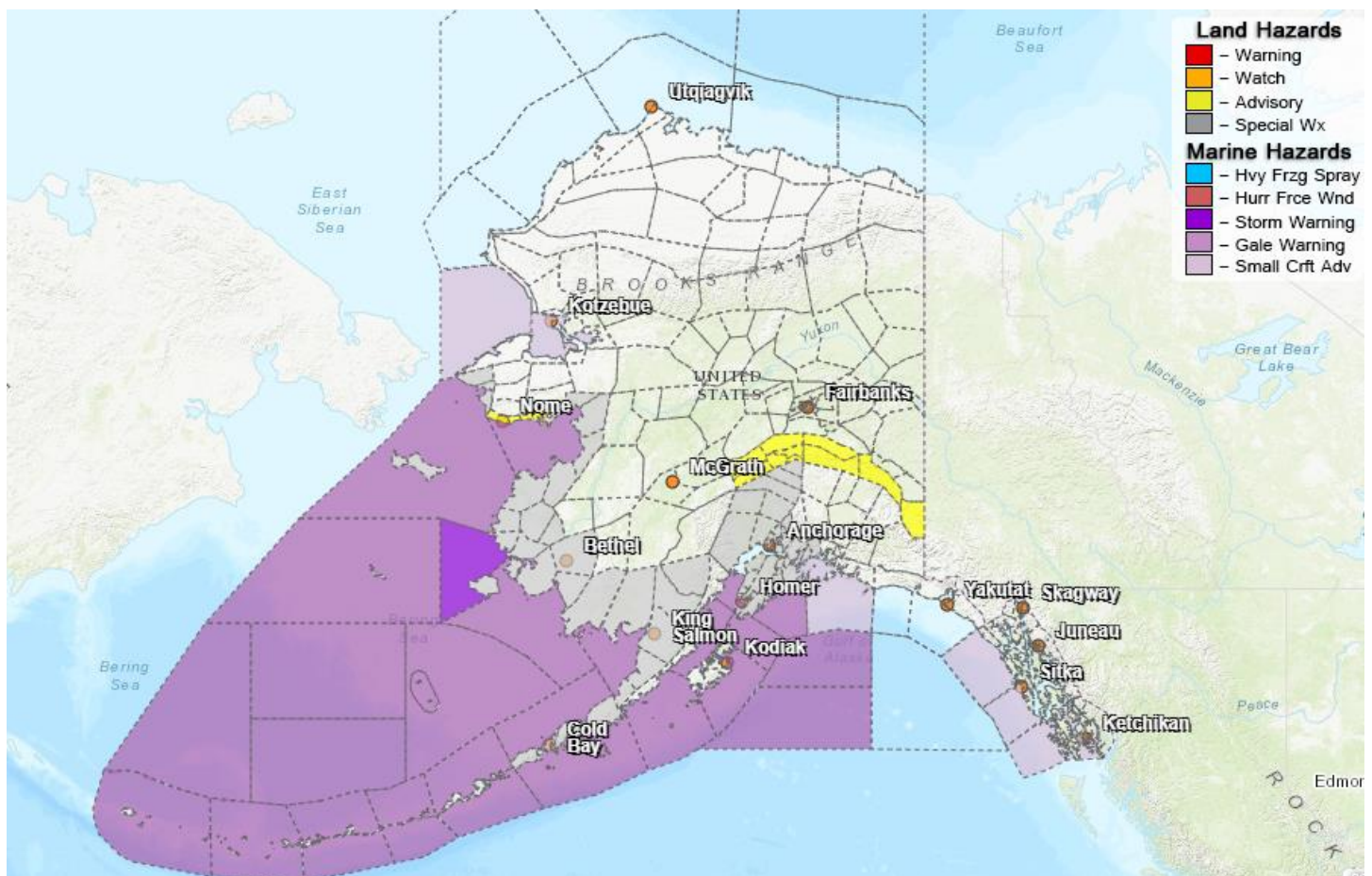
The Alaska Interagency Coordination Center is at Preparedness Level 2.

## Significant Weather:



A wind advisory is in effect for the passes through Denali and the eastern Alaska Range until 1 am Friday.

A high surf advisory is in effect for the southern Seward Peninsula coast until 10 am Thursday.

There is a special weather statement for high water on northwest Alaska rivers this week, due to rainfall.

There are multiple special weather statements regarding a strong fall storm moving into the Bering Sea today.
