

Significant Weather:



Several Coastal Flood Warnings have been issued for Norton Sound, the Seward Peninsula, the Lower Yukon Delta, in effect from Friday morning through Sunday morning. Water levels up to 10 feet above normal high tide and coastal erosion are likely.

A Special Weather Statement is in effect for coastal areas between Newtok and Hooper Bay for possible coastal erosion from Thursday night through Saturday morning.

Coastal Flood Advisories have been issued for Saint Lawrence Island, Baldwin Peninsula, Selawik Valley, Chukchi Sea Coast, and the Bering Strait Coast, in effect from Friday morning through Sunday morning. Water levels up to 5 feet above normal high tide and coastal erosion are likely.

Several Winter Weather Advisories and storm warning have been issued for the central and eastern Interior, including Denali, Lower Kobuk and Noatak Valleys, Eastern Alaskan Range, Southeastern Brooks Range, and associated areas, for snowfall into Saturday morning.

A Dense Fog Advisory is in effect for the Eastern Chichagof Island and Glacier Bay areas until 11am this morning. There are also Dense Fog Advisories in affect until 10am this morning for the Central Interior and Middle Tanana Valley areas.
