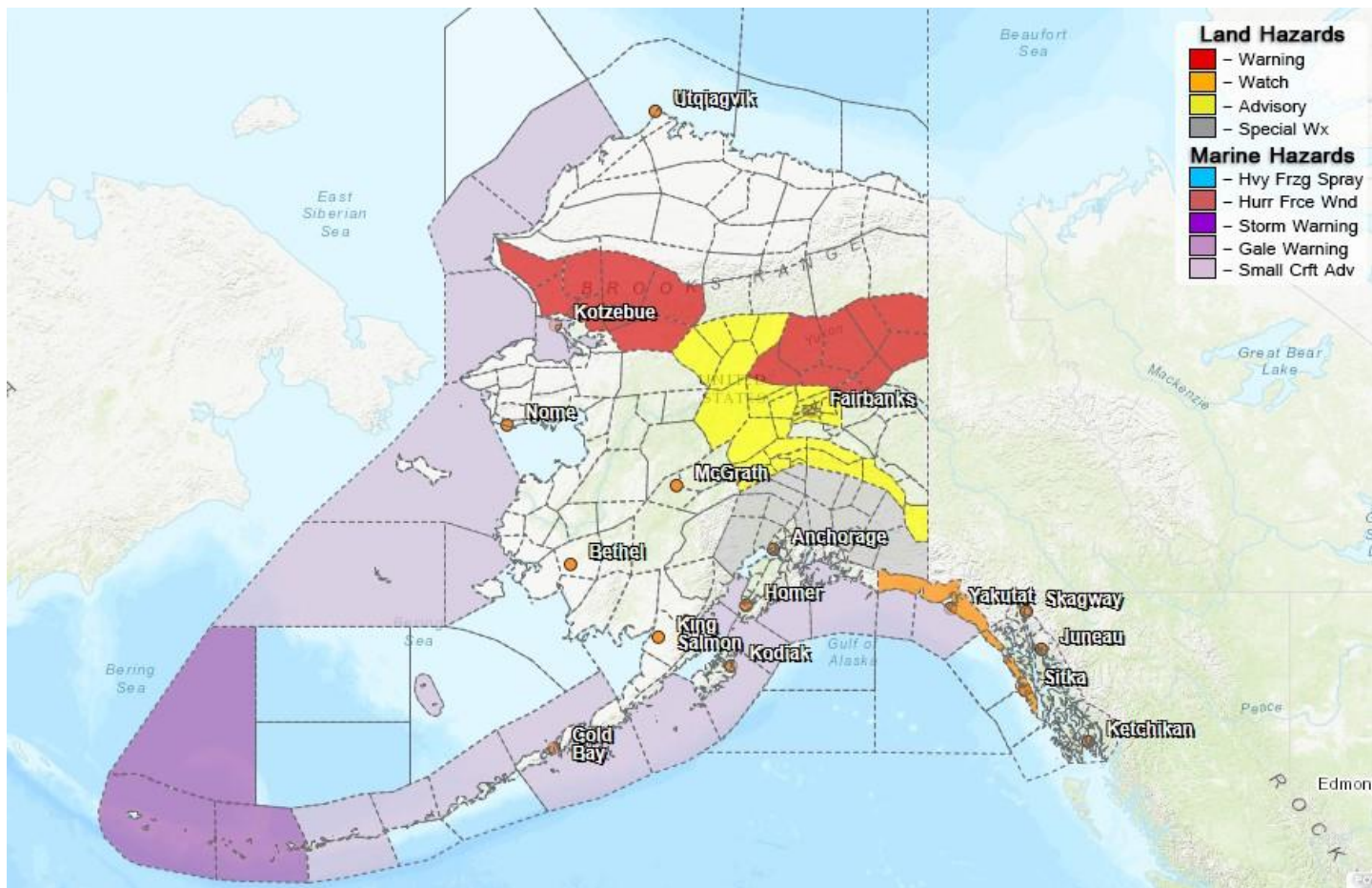

Several Winter Weather Advisories have been issued for the central Interior, including Denali, Upper Koyukuk Valley, Middle Tanana Valley, Easter Alaska Range, and associated areas, for snowfall and poor visibility into Wednesday evening.

Winter Storm Warnings are in effect for Upper Kobuk and Noatak Valleys, Lower Kobuk, and associated areas. This warning is in effect through Wednesday evening.

A high wind watch is in effect for Cape Decision to Salisbury Sound Coastal area and surrounding areas through Friday, October 11th.

A Special Weather Statement has been put out regarding winter driving conditions along the Parks Highway north of Talkeetna and the Richardson Highway north of Paxson.
