

#### Significant Weather:



A winter weather advisory is issued for this morning into Wednesday evening for the areas of Taiya Inlet and the Klondike Highway. Four to six inches of heavy, wet snow is expected near White Pass and driving is expected to be hazardous.

Special weather statement for elevated surf into Thursday has been issued for the St. Lawrence Island and Bering Strait Coast. Northeasterly winds with gusts up to 50mph are expected for St Lawrence Island and Diomede late Wednesday into early Thursday. Residents should move possessions well above the normal high tide line in preparation for this event.

A wind advisory is in effect for the Denali area and Eastern Alaska Range through Thursday morning.

A high wind warning is in effect for Anchorage and the Western Prince William Sound through Wednesday at noon.

A special weather statement for coastal erosion and rough surf possible from Port Moller to Egegik, including Port Heiden, is in effect for Wednesday afternoon through Thursday evening. Sustained winds between 35-45mph are likely. Residents in the area can prepare by securely tying property down or moving items from the immediate coast.
