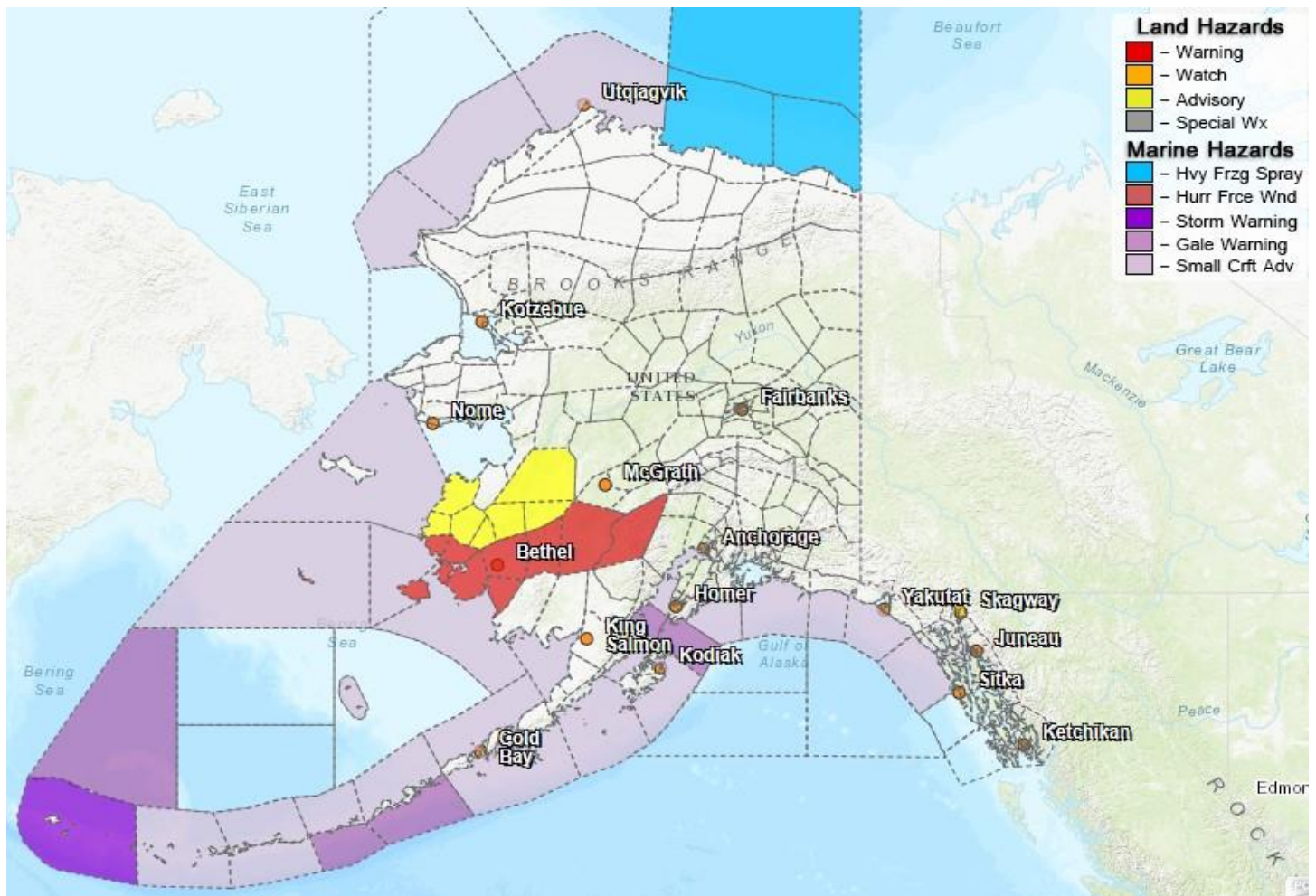

Significant Weather:



A winter weather advisory is in effect until the morning of November 7th for the Central Interior, Yukon Flats and Surrounding Uplands, Middle Tanana Valley, Central and Eastern Beaufort Sea Coast, Eastern Norton Sound and Nulato Hills, and the Lower Koyukuk and Middle Yukon Valleys.

A winter storm warning is in effect until the morning of November 6th for the Upper and Lower Kuskokwim Valley, Kuskokwim Delta, Middle Tanana Valley, Yukon Delta, and the Lower Yukon Valley.
