

## Significant Weather:



A wind advisory is in effect for the Lower Yukon Valley, Lower Koyukuk and Middle Yukon Valleys, and the Upper Kobuk and Noatak Valleys.

A high wind warning is in effect for St. Lawrence Island and the Bering Strait Coast.

A winter storm warning is in effect for the Eastern Alaska Range, Upper Tanana Valley and the Fortymile Country, Upper Koyukuk Valley, Yukon Flats and Surrounding Uplands, and the Central Interior.

A winter weather advisory is in effect for the Middle Tanana Valley, Deltana and Tanana Flats, and the Copper River Basin.

A winter storm watch is in effect for the Anchorage area, Matanuska Valley, and the Western Kenai Peninsula.

A blizzard warning has been issued for Northeast Prince William Sound through Thursday at 1500hrs.

A special weather statement has been issued for the Central Interior; Deltana and Tanana Flats; Denali; Eastern Alaska Range; Middle Tanana Valley; Upper Koyukuk Valley; Upper Tanana Valley and the Fortymile Country; Yukon Flats and Surrounding Uplands. Strong winds and snow are expected to increase Wednesday morning and increase through Friday morning. Wind gusts up to 50mph are expected with up to 6in of snow potentially from Fairbanks to Tok. Delta Junction is expected to receive up to 12in.
