Air Quality Index (AQI) Advisories


The Matanuska-Susitna Borough is issuing an air quality advisory for Butte and surrounding communities valid through Monday November 18th.

Significant Weather:



Winter storm warnings in effect until Wednesday for the Yukon Delta, Yukon Valley, Eastern Norton Sound, Lower Koyukuk, Upper and Lower Kuskokwim Valley areas for heavy mixed precipitation, snow accumulations up to 6 inches.

Winter storm watch in effect until Wednesday for the Susitna Valley for heavy snow possible. Total accumulation of 4-12 inches possible.

Winter Weather advisory in effect until Tuesday morning for the Bristol Bay region, specifically north of Dillingham for snow accumulation up to 5 inches.

Blizzard Warning in effect until Tuesday afternoon for the Kuskokwim Delta for snow accumulation up to 12 inches with blowing winds of 35-45 mph.

High wind warning in effect until Wednesday afternoon for St. Lawrence Island and the Bering Strait Coast for winds of 30-50 mph with gusts up to 65 mph.

High wind watches and winter weather advisories are in effect until Wednesday afternoon for the Deltana and Tanana Flats, Denali, Eastern Alaska Range, and the Central Interior. Winds of 35-45 mph with gusts up to 70 mph are possible with snow accumulation of 4-7 inches expected.
