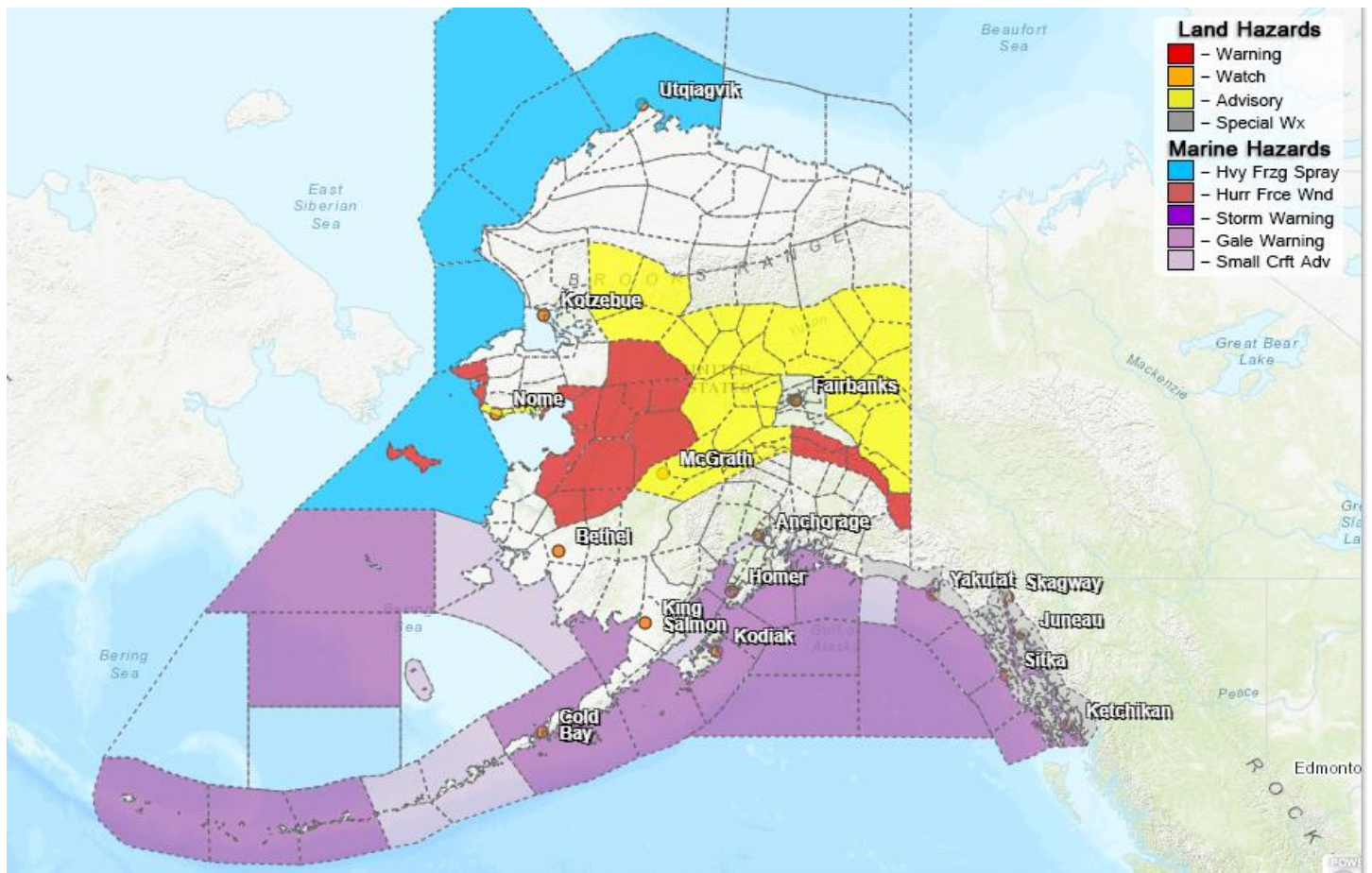

Significant Weather:



Multiple winter weather advisories are in effect for Wednesday afternoon and into Wednesday evening for the Yukon flats, Central Interior, Upper Koyukuk Valley, Southern Seward Peninsula Coast, and the Upper Kuskokwim Valley areas.

Winter storm warnings in effect until Wednesday afternoon for the Eastern Norton Sound, Lower and Middle Yukon Valleys for heavy snow fall up to 8 inches.

Winter weather advisories are in effect until Thursday morning for Denali areas, Upper Kobuk and Noatak Valleys due to blowing snow and low visibility.

Winter storm warnings in effect until Thursday morning for the Lower Koyukuk Valley, Middle Yukon Valley, and the Eastern Alaska Range for heavy snowfall up to 12 inches.

High wind warning and High Surf Advisory in effect until Friday afternoon for St. Lawrence Island and the Bering Strait Coast for winds of 30-50 mph with gusts up to 65 mph.

A hydrologic outlook is in effect for this week for heavy rains across Southeast Alaska. At this time 2-4 inches of rain is expected from Thursday afternoon through Friday night.
