

A Winter Weather Advisor has been Issued for Cape Fairweather to Cape Suckling Coastal Area until Wednesday evening.

A High Wind Warning has been issued for Cape Decision to Salisbury Sound Coastal Area, Dixon Entrance to Cape Decision Coastal Area, Inner Channels from Kupreanof Island to Etolin Island, Southern Inner Channels through 3:00 am AKST tomorrow morning.

Blizzard Warnings have been issued to Northeast Prince William Sound and Kodiak Island until 12:00 pm and 6:00pm AKST respectively.

Wind Chill Advisories remain in effect through 6:00 pm AKST Wednesday for the Eastern Alaska Range, The Central Beaufort Sea Coast, Eastern Beaufort Seat Coast, and Thursday for Yukon Flats and Surrounding Uplands, Central Interior, Denali, Chukchi Sea Coast, Lower Kobuk and Noatak Valleys, Baldwin Peninsula and Selawik Valley, Northern and Interior Seward Peninsula, Eastern Norton Sound and Nulato Hills, St. Lawrence Island and Bering Strait Coast, Yukon Delta, Yukon Valley, Upper Kobuk and Noatak Valleys, Northeastern Brooks Range, Kuskokwim Delta, and Bristol Bay

A Winter Storm Warning remains in effect for Taiya Inlet and Klondike Highway, Haines Borough and Lynn Canal, including the cities of Skagway and Haines, until 6:00 pm.
