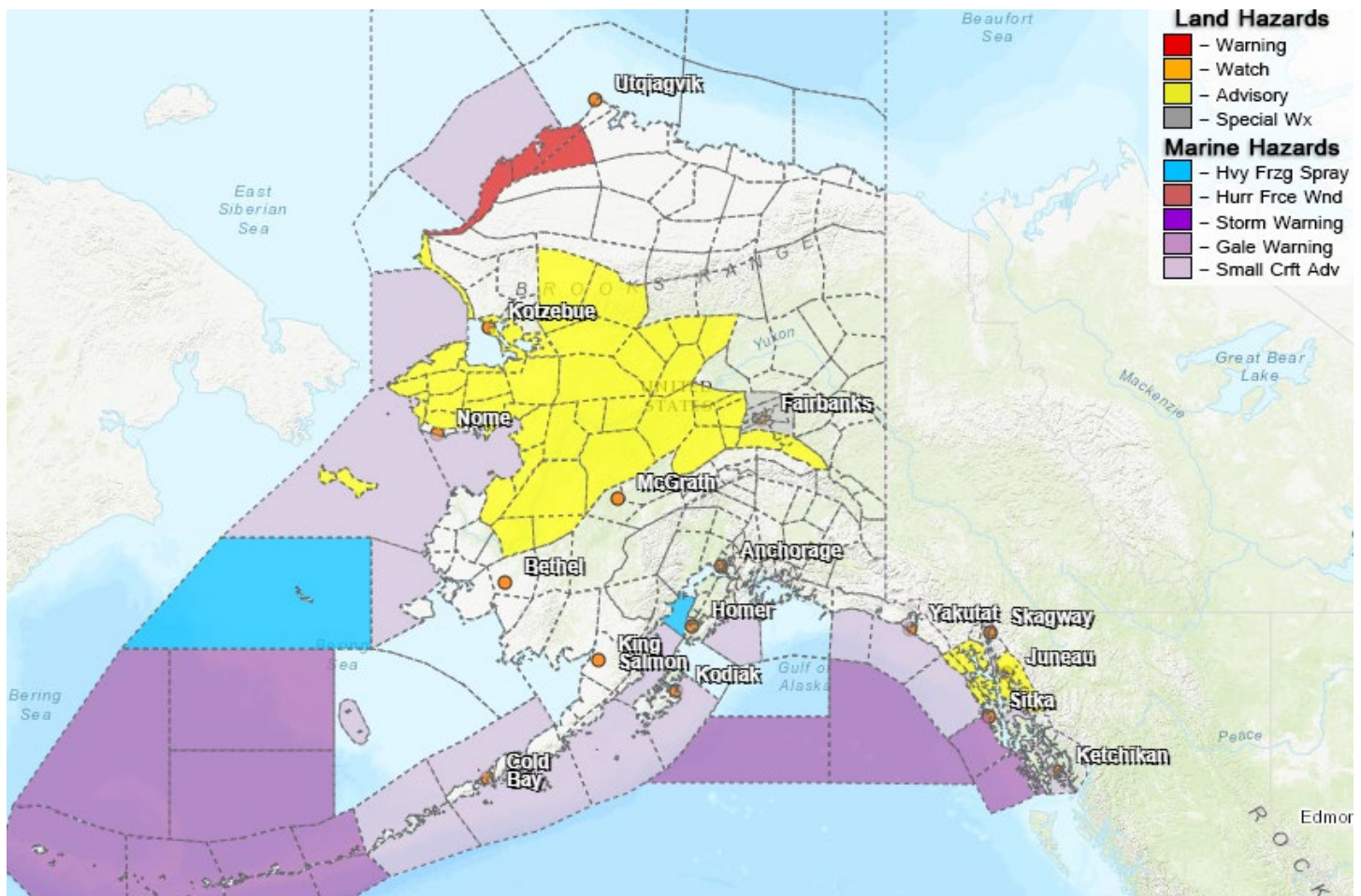

Wind Chill Advisories are in effect until 6:00 am Saturday for Eastern Chichagof Island; Glacier Bay; Juneau Borough and Northern Admiralty Island; Salisbury Sound to Cape Fairweather Coastal Area, 12:00 pm Saturday for the Deltana and Tanana Flats, Chukchi Sea Coast, Baldwin Peninsula

and Selawik Valley, Northern and Interior Seward Peninsula, Eastern Norton Sound and Nulato Hills, St Lawrence Island and Bering Strait Coast, Lower Yukon Valley, Lower Koyukuk and Middle Yukon Valleys, Upper Kobuk and Noatak Valleys, Western Arctic Coast, and 6:00 am Sunday for Upper Koyukuk Valley, Central Interior
