**Coronavirus (COVID-19) Pandemic**

A unified command has been established at the SEOC. The SEOC Preparedness Level remains at Level 3 for this event.

**2020 Fire Season**

The Alaska Interagency Coordination Center, (AICC) is at Preparedness Level 2.

Wildland fire totals for 2020:

- Total Fires = 143
- Total Acres = 13,871

There are currently 52 active fires with 4 fires currently staffed.

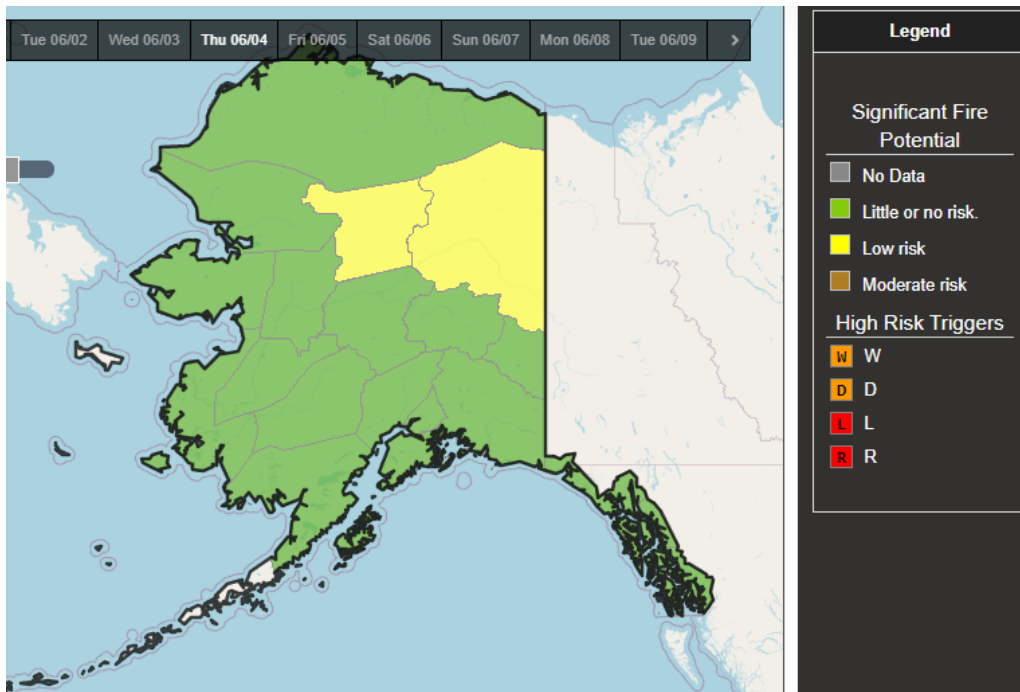
