Coronavirus (COVID-19) Pandemic

A unified command has been established at the SEOC. The SEOC Preparedness Level remains at Level 3 for this event.

2020 Fire Season

The Alaska Interagency Coordination Center, (AICC) is at Preparedness Level 3.

Wildland fire totals for 2020:

- Total Fires = 258
- Total Acres = 164,654

There are currently 102 active fires with 4 fires currently staffed.

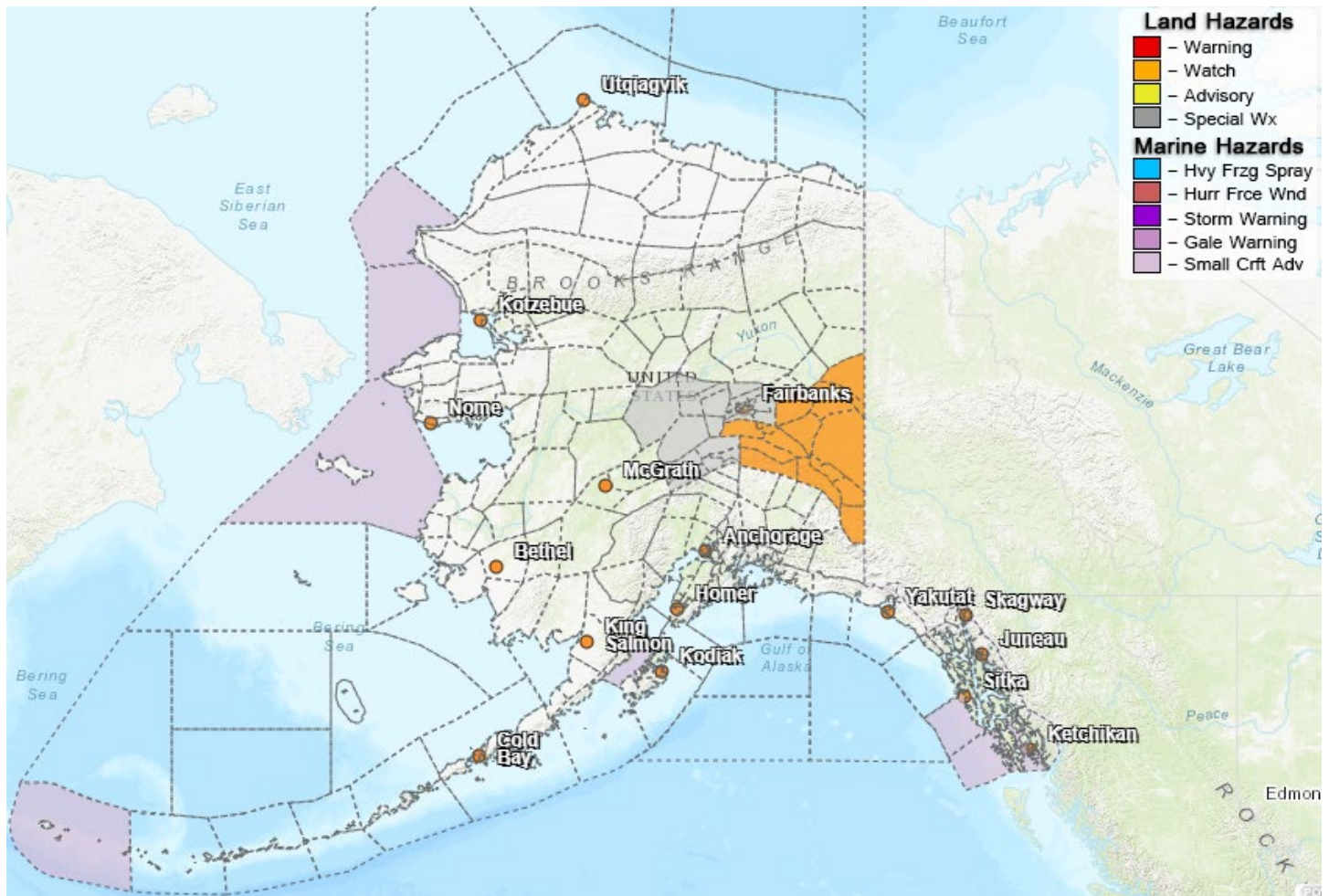

Significant Weather:



Flood watches for streams and rivers are in effect through Wednesday evening for the following areas:

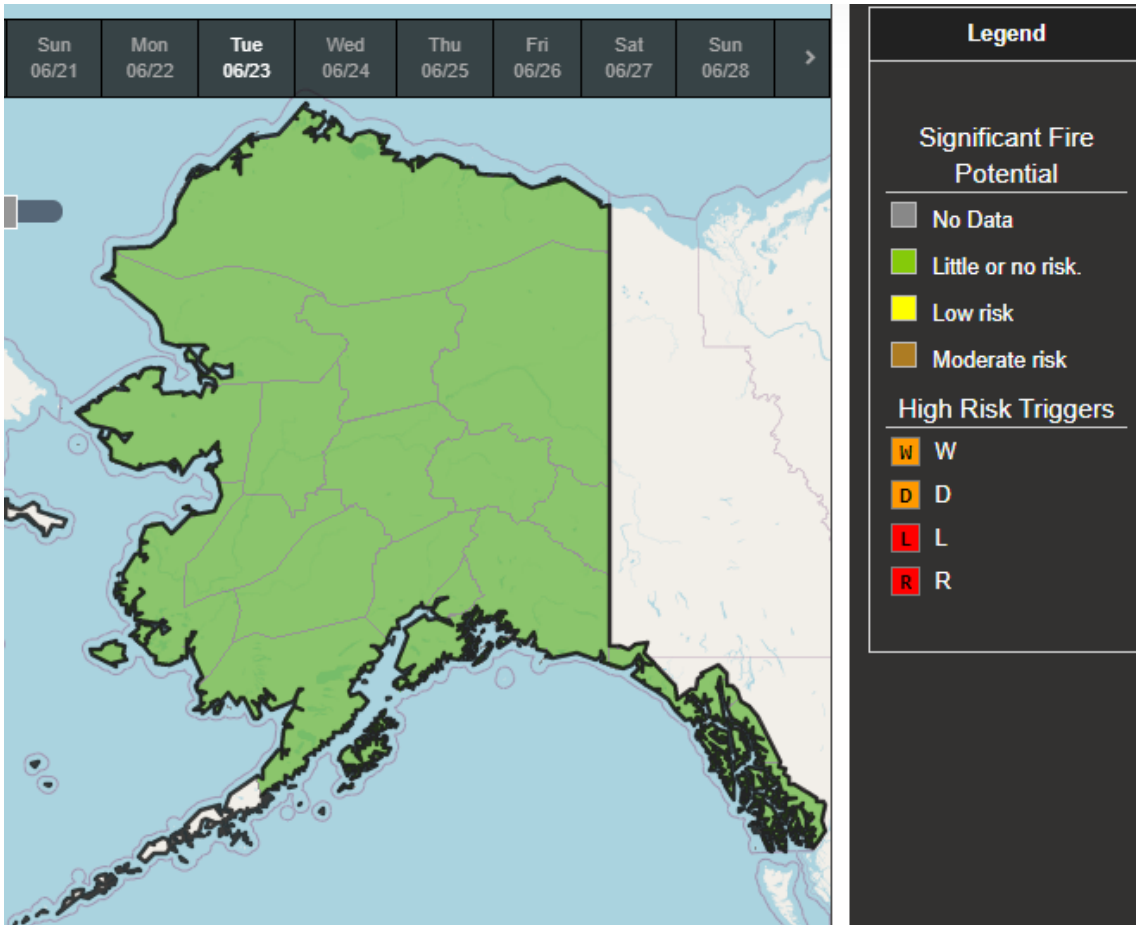
- Deltana and Tanana Flats from the Little Delta River east.
- Upper Tanana Valley and the Fortymile Country.
- Eastern Alaska Range from the Little Delta River east.

Another 1-2" of rainfall has fallen across parts of the Fortymile Uplands into the Tanana Valley. Another 1-2.5" is expected through Tuesday, mostly across the Fortymile Uplands with lesser values westward into the Upper Tanana Valley and White Mountains. Rivers across the Interior south of the Yukon River are expected to have sharp rises through Monday and Tuesday and will continue to rise to near bankfull. Rivers to watch include the Tanana, Fortymile, Goodpaster, and Salcha Rivers. Other rivers which are expected to have sharp rises and bear watching include the Chena, Charley, and Salcha Rivers. Residents in these areas should remain alert and have backup safety plans. As always, close monitoring of the situation will continue as this current rain event and associated river rises unfold.
