A unified command has been established at the SEOC. The SEOC Preparedness Level remains at Level 3 for this event.

2020 Fire Season

The Alaska Interagency Coordination Center, (AICC) is at Preparedness Level 1.

Total Fires = 300

Total Acres = 175,515

There are currently 82 active fires with 3 fire currently staffed.

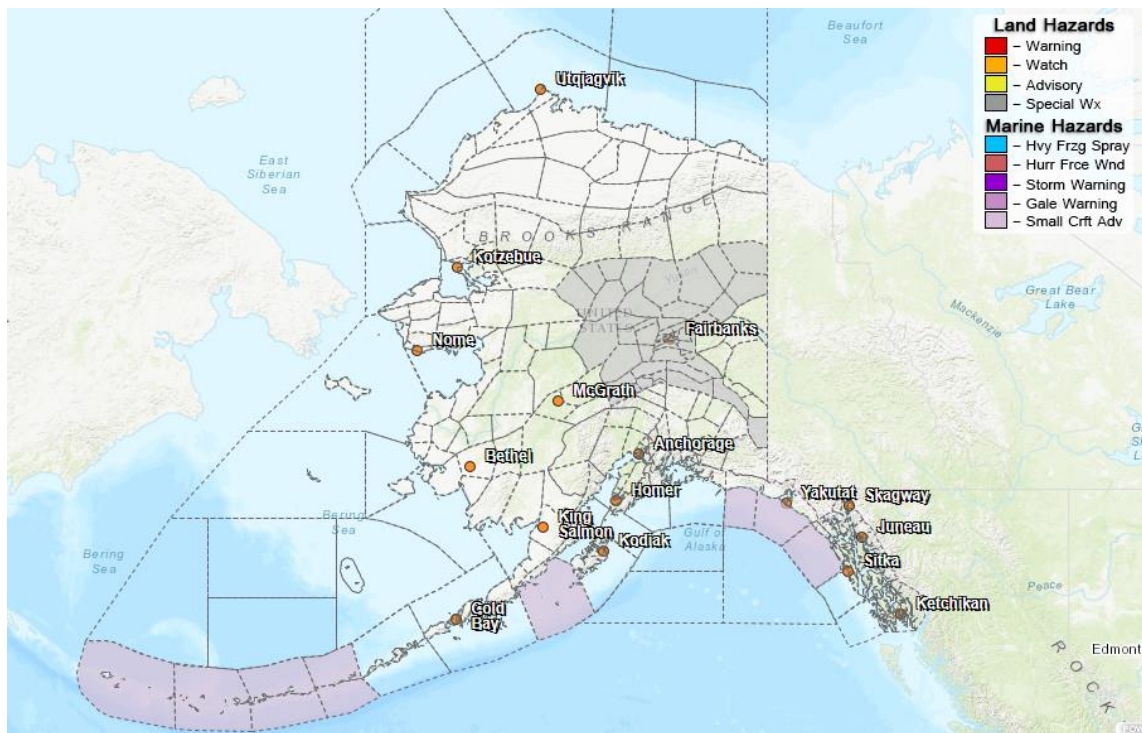

Significant Weather:

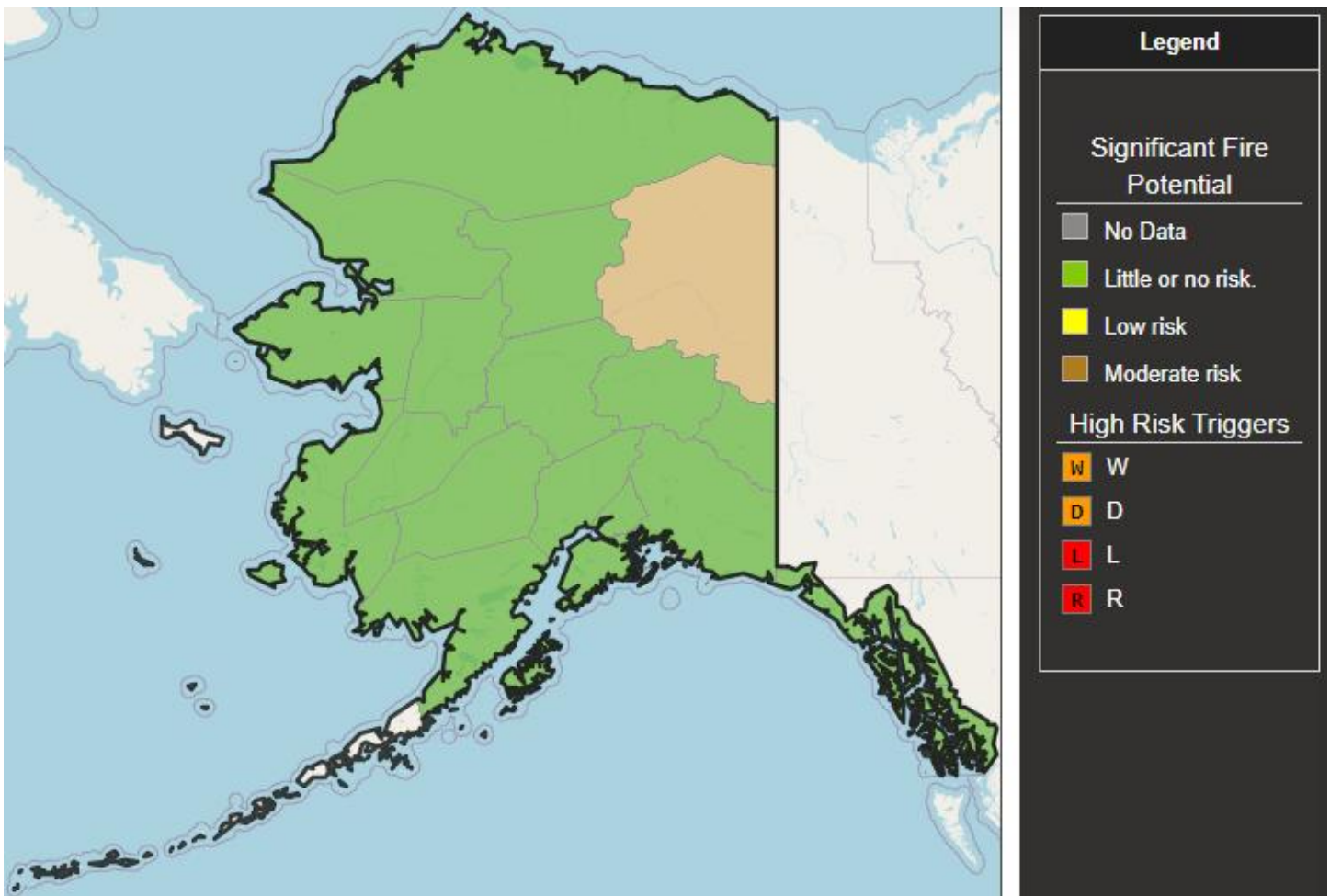


A special weather statement has been issued for strong thunder storms in the interior. An area of strong thunderstorms is expected to develop this afternoon from Fairbanks north to Finger Mountain and then spread southwest to Minchumina to Huslia tonight. Expect scattered thunderstorms with frequent lightning, hail, strong gusty winds, and brief heavy rains. Some hail could be large. Rainfall up to 0.50 inch through tonight could cause minor flooding on small streams, and in urban areas. This is expected to affect Fairbanks this afternoon and evening. Isolated thunderstorms will occur today in other areas of the Eastern Interior today. Expect some thunderstorms to continue through the night tonight.
