Significant Issues

Sand Point 5.9 Aftershock

At 12:04am on 7/28 there was a magnitude 5.9 aftershock to last weeks magnitude 7.8 earthquake near Sand Point, the National Tsunami Warning Center issued a Tsunami information statement at 12:11am stating a tsunami was not expected. Due to the magnitude of the aftershock, the SEOC Duty officer contacted the three communities closest to the epicenter to check for impacts. Although each community felt the aftershock, no issues were reported. The SEOC will continue to monitor aftershocks in the region as well as communicate with the communities for ongoing damage assessments.

Delta River Flooding

DOT&PF continues to work to divert water from the road way while they evaluate river conditions to determine a long term solution of redirecting water flow. The SEOC will continue to monitor the situation and be in contact with DOT&PF for further updates.

Coronavirus (COVID-19) Pandemic

A unified command has been established at the SEOC. The SEOC Preparedness Level remains at Level 3 for this event.

2020 Fire Season

The Alaska Interagency Coordination Center, (AICC) is at Preparedness Level 1.

Wildland fire totals for 2020:

Total Fires = 312

Total Acres = 180,176

There are currently 50 active fires with 0 fires currently staffed.

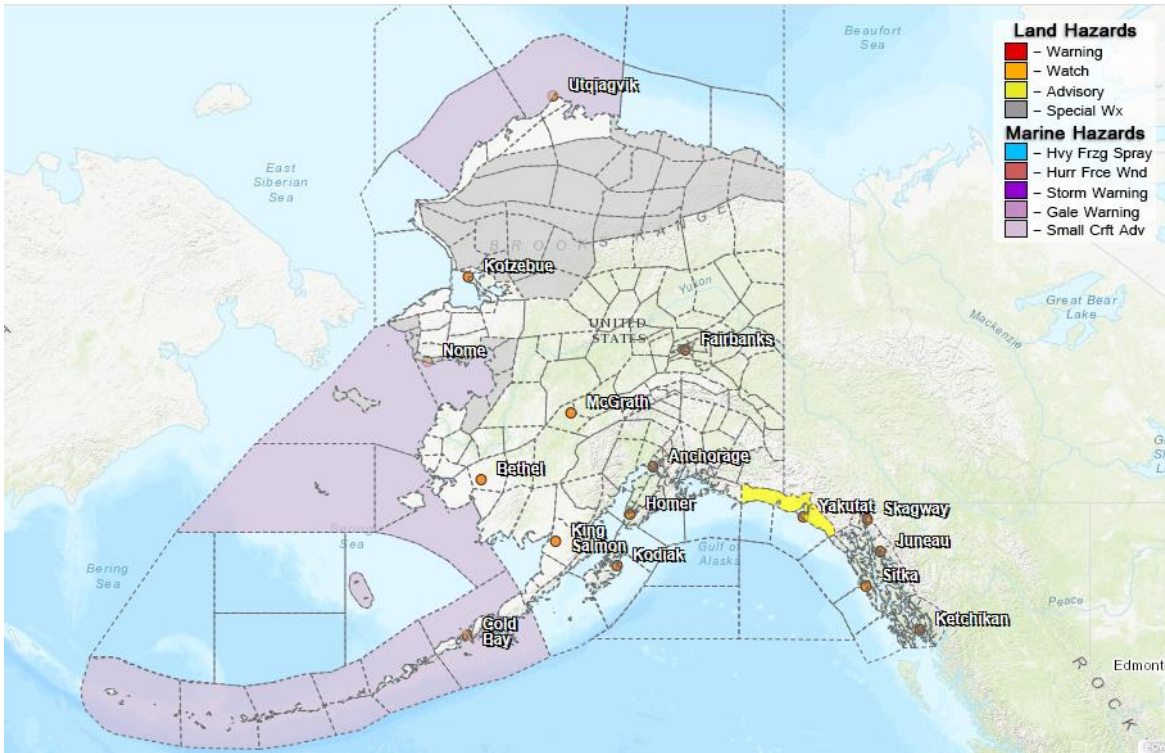

Significant Weather:



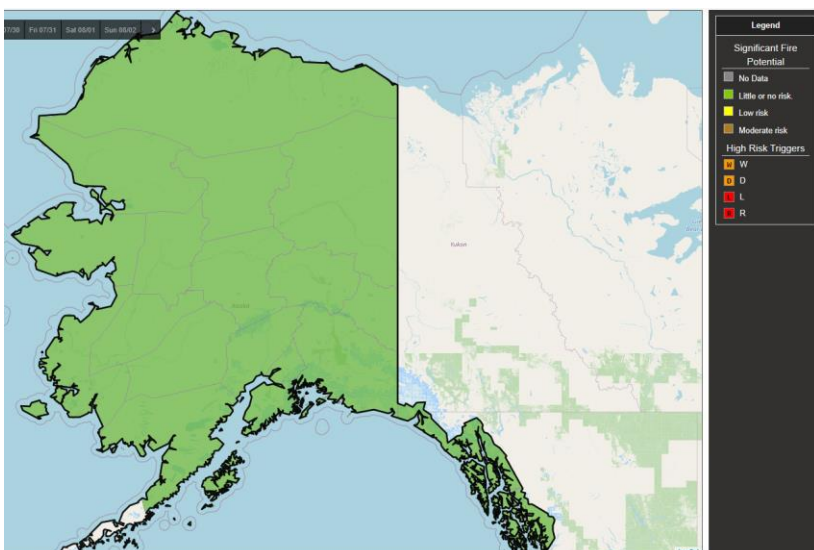
Dense fog advisory in effect until 9:00am this morning for Yakutat
