

Significant Weather:



A Dense Fog Advisory is in effect until 1:00 P.M. today for the Anchorage, Mat-Su, and Western Kenai Peninsula area.

A Special Weather Statement has been issued for the Northern and Western Arctic Coasts until 8:00 P.M. today. Northwest winds of up to 20mph will push the surf 1 to 3 feet above the normal tide line throughout the area.

A Special Weather Statement has been issued for the Baldwin Peninsula and Selawik Valley Chukchi Sea Coast. North facing coastlines should expect surf levels to be pushed up 1 to 3 feet above the normal high tide line by 20 to 35mph winds. There is the potential for erosion and minor flooding along the coastline from Kotzebue to Wales.
