

Significant Weather:



A Flood Advisory is in effect for the Taiya Inlet and Klondike Highway and Northern Inner Channels due to heavy rainfall until noon Friday

A Special Weather Statement remains in effect for periods of heavy rain that will impact Southeast Alaska through today.

A Wind Advisory is in effect for the Eastern Alaska Range, Deltana and Tanana Flats for winds 25-35 mph with gusts up to 65mph until 1pm Friday.

A Special Weather Statement has been issued for the Brooks Range, Kobuk, Koyukuk, and Noatak Valleys. Heavy rainfall is expected from Thursday evening into Friday morning. A sharp rise in rivers in the area is expected through the weekend.
