Chena Hot Springs Road / Munson Creek Fire:

The Fairbanks North Star Borough reduced the Munson Creek Fire Evacuation notice from “Go” to “Set”. This change means residents in the affected area are no longer being asked to evacuate but should be prepared to do so if the need arises.

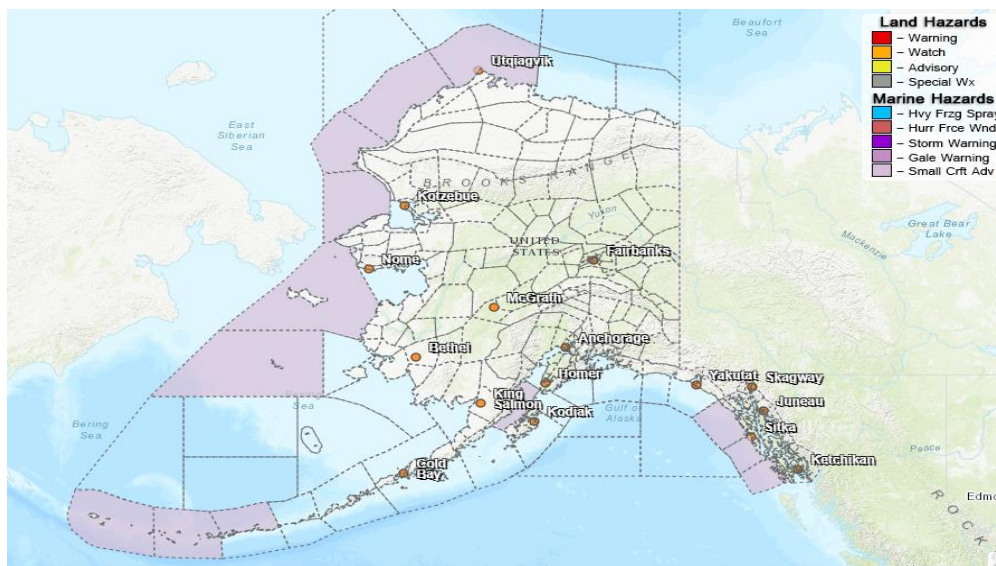

Significant Weather:



A Flood Advisory is in effect until Friday evening for the Kennicott River near McCarthy. The Hidden Lake dam has begun to release and will cause a significant rise in the river. Water levels are expected to rise 2 to 5 feet over the next 24 to 48hrs. The Chitina and Copper Rivers will experience moderate rises in water levels as the glacier dammed outburst continues downstream.
