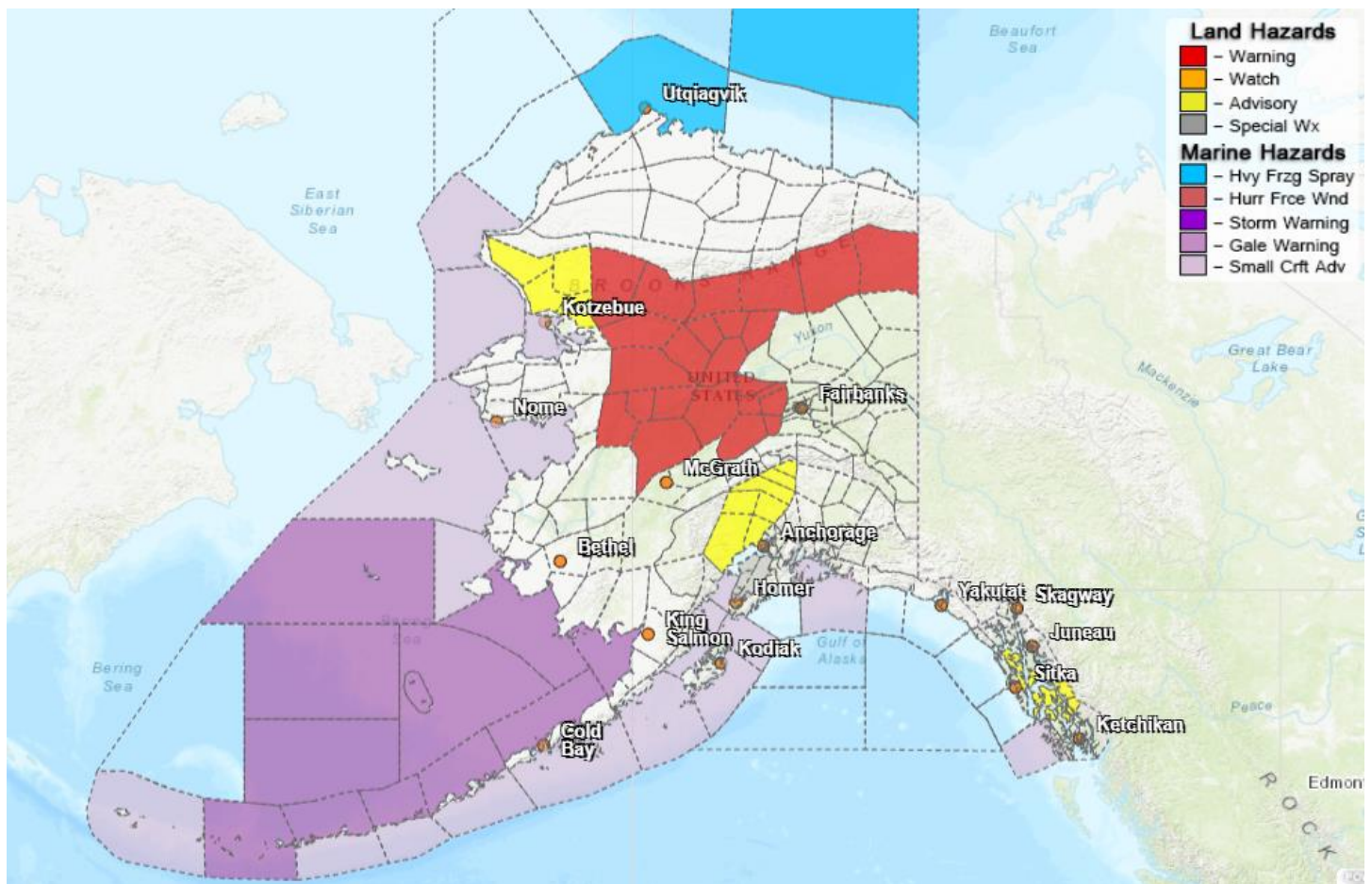

Significant Weather:



A Winter Storm Warning for heavy snowfall remains in effect for the Southeastern Brooks Range, Central Interior, Koyukuk, Kobuk, Noatak and Middle Yukon Valleys through Thursday night.

A Dense Fog Advisory is in effect until 10:00 A.M. today for Wrangell, Petersburg, Angoon, Hoonah, and Tenakee Springs.

A Winter Weather Advisory for up to 12 inches of heavy snowfall has been issued for the Susitna Valley north of Talkeetna from 1:00 A.M. Wednesday through Thursday morning.

A Special Weather Statement remains in effect for the Western Kenai Peninsula. The Skilak Glacier dammed Lake is releasing water, resulting in elevated water levels on Skilak Lake and the Kenai River. The water is expected to crest around bankfull within the next two days, and no flooding is expected.
