

Significant Weather:



Wind Chill Advisories and Warnings are in effect for the following areas:

- Western Arctic coast and the southeastern Brooks Range until noon today. Wind chills as low as 50°F below zero are possible.
- Northeastern Brooks Range until noon tomorrow. Wind chills as low as 60°F below zero are possible.

A Winter Storm Watch is in effect from Thursday evening through Friday morning for St. Lawrence Island and the Bering Strait coast. 2 to 4 inches of snow accumulation and winds gusting to 55mph are possible across the region.

Winter Weather Advisories are in effect for the following areas:


- Chukchi Sea Coast near Point Hope until noon today. Strong winds and blowing snow are possible.
- Much of the Alaska Panhandle from Yakutat south to Hyder from 3:00 P.M. today through tomorrow afternoon. 4 to 9 inches of snow accumulation is possible.

Special Weather Statements remain in effect for the following areas:

- Central Panhandle. Winds in the region are expected to increase in speed throughout the day today and change in direction this afternoon and evening. Peak gusts of up to 55mph are possible.
- Southern Seward Peninsula and the western Interior. A major storm could impact the area late this weekend with high winds and heavy snowfall.
