Significant Issues:

Southcentral Wildland Fire Activity:

Over the weekend, with Red Flag Warnings in effect, SEOC was in regular contact with the Kenai Peninsula Borough, Matanuska-Susitna Borough, and the Municipality of Anchorage Emergency Management concerning fire conditions and active fire responses in their jurisdiction.

Burn ban issued for the Municipality of Anchorage. Ban prohibits open burning of any kind in the Anchorage area and is in effect until further notice.

River Watch 2022

Flood warning in effect for Buckland River in effect until 4pm Monday.

Flood advisory for snowmelt in along Moose Creek and Glennallen north of Glenn Hwy **has been expanded to include the Gulkana River and around Lake Louise in effect until Monday afternoon.**

Flood watch remains in effect for The Yukon River from Grayling to Russian Mission due to ice jam until Friday evening.

Flood watch for snowmelt flooding in effect for China River from North Pole to Chena Hot Springs through Monday morning.

Flood watch for snowmelt flooding the Salcha River for Deltana and Tanana Flats areas from Friday evening through Monday.

Flood watch for snowmelt flooding the Slacha River for Upper Tanana Valley and Fortymile Country from Friday evening through Monday.

The 2022 Spring Floods, the 2022 Lowell Point Landslide in the City of Seward, and the Galena Fire Hall roof collapse will now be eligible for State of Alaska disaster recovery programs. Individuals and families can now apply for state disaster grants. See <https://ready.alaska.gov/> for details.

The Riverwatch teams have been demobilized, and have transitioned to flood response and recovery. Continuing to monitor for potential snow melt flooding concerns.

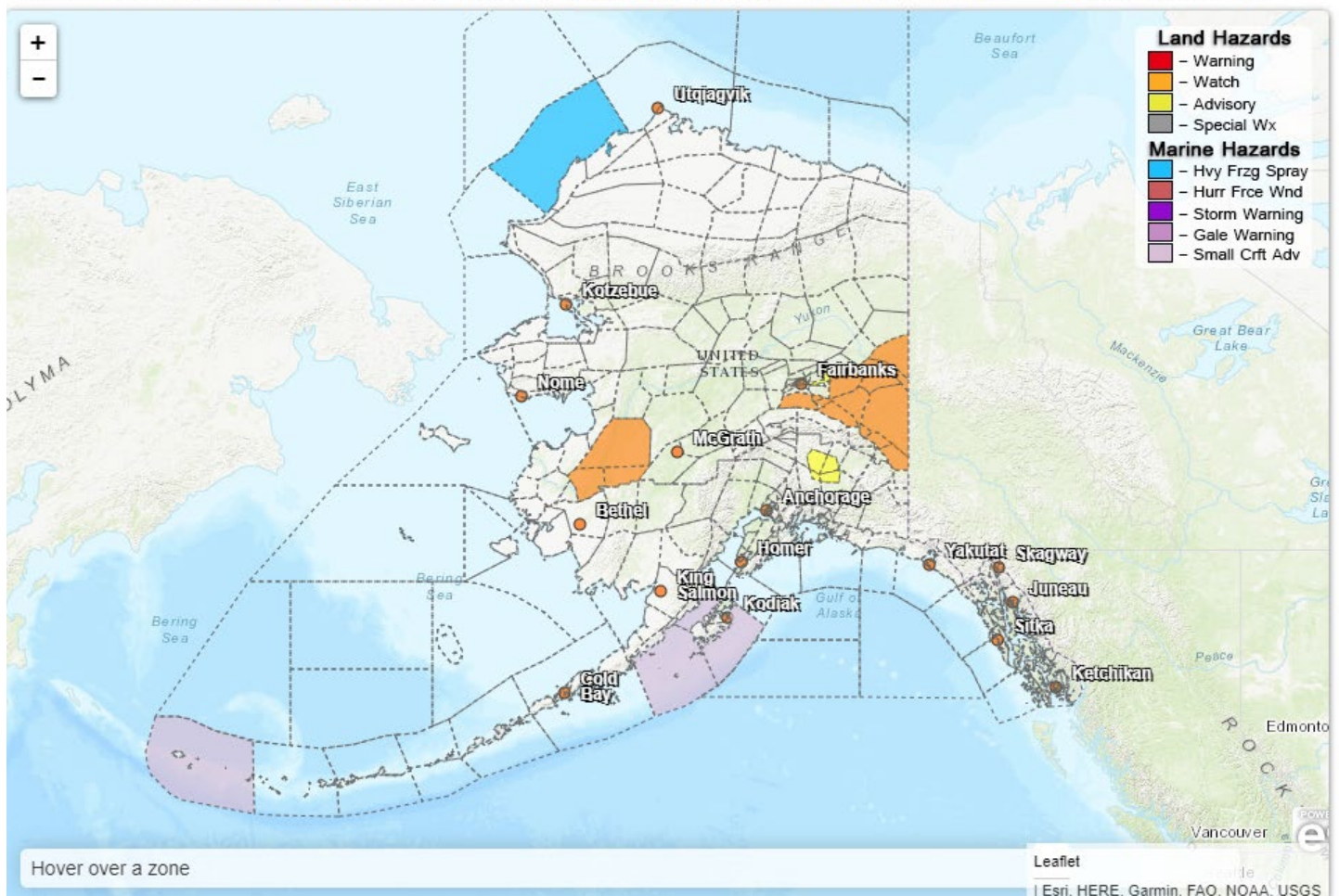
