#### **Significant Issues:**

Richardson Highway remains closed from MP 218 to MP 234 due to wash out flooding. DOT anticipates this closure will continue through the weekend, depending on weather. For travel to Valdez, detour around the closure by using the Tok Cutoff and the Alaska Highway.

#### **Statewide Fires**

Team working on Clear Fire #346 made decision to reduce evacuation GO status area back to SET for area E. of Nenana River and South of Clear Spaceforce Base. Evacuation GO remains in effect for areas West of Parks Highway between MP 275 and Rex Bridge over the Nenana River. Despite GO evacuation statuses in area, emergency shelters remain vacant but ready at this time.

For Middle Tanana Complex, evacuation levels on Goodpaster River were announced over the weekend consistent with those in the Salcha River corridor. River mile 0 to river mile 8.6 is now in READY status. River mile 8.6 to river mile 33.9 is in SET status. From the confluence with the South Fork Goodpaster River to Seven Mile Creek is in READY. The group of cabins along Goodpaster River at the mouth of Central Creek is in SET status. Shaw Creek Road and Pogo Mine area are in READY Status.

With over 2,800,000 acres now burned statewide, there are 269 active fires with 17 staffed with personnel on the ground. The Alaska Interagency Coordination Center continues at wildland fire Planning Level 5, the highest level.

SEOC remains at Preparedness Level 2 - *Heightened Awareness* in response to the statewide fire situation. SEOC is monitoring multiple fires that pose some risk to communities and is participating regularly in Incident Management Team Cooperator briefings for these fires.

SEOC has a Disaster Division Supervisor and the Mobile Emergency Operations Center at the Minto Lakes Fire (#349) to support fire operations and coordinate with Fairbanks North Star Borough (FBNSB) Emergency Management. Several areas of the FBNSB in the Chatanika River Corridor remain evacuated with a shelter location at the Randy Smith Middle School and pet shelter at the Fairgrounds ready if needed.

SEOC is in regular contact with both Denali and Fairbanks North Star Borough's Emergency Management coordinating state support on multiple fires. SEOC has multiple staff engaged in fire response support operations and is in daily contact with State Forestry for contingency planning of mass care, evacuation, National Guard, and other resources.


