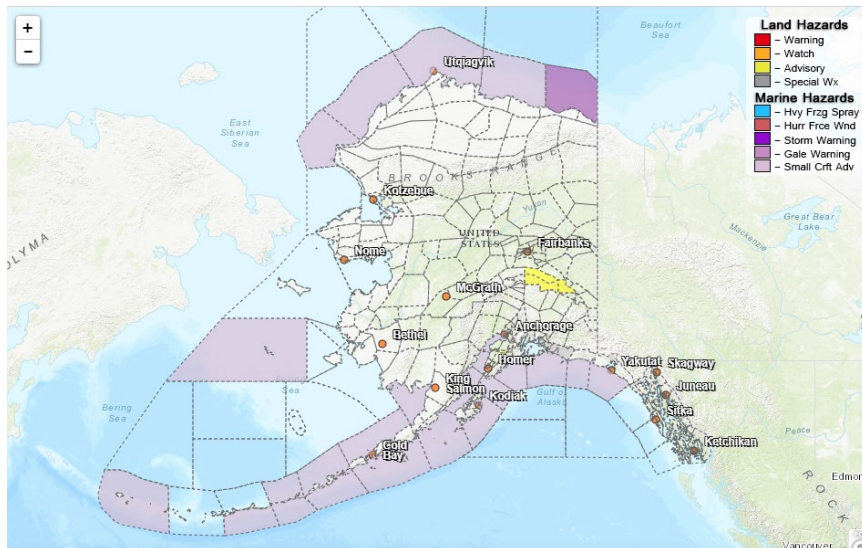

Significant Weather:



Flood advisory issued for Western Kenai Peninsula through 5:00PM Wednesday. Mainstream Kenai River is likely to experience minor flooding, with worst conditions expected from Kenai Lake to Funny River. Some Low-water crossing may become impassable.

Special weather statement issued for Southeast Prince William Sound. Glacier dammed lake released causing debris to flow into Controller Bay. High water and possible flooding expected.

Wind advisory issued for Eastern Alaska Range from 10:00PM this evening through 7:00PM Tuesday. South winds gusting to 55mph expected.
