

Significant Weather:



The following weather watches, warnings, or advisories have been issued:

- A High Surf Advissory is in effect until noon today for the Kuskokwim Delta coast. Water levels are expected to rise 2 to 5 feet above the normal high tide line.
- A Flood Advisory is in effect until 10:00 P.M. today for the Situk River near Yakutat. Minor flooding
 is likely in low lying areas.
- A Dense Fog Advisory is in effect until 10:00 A.M. today for the Petersburg Borough.
- A Special Weather Statement has been issued for a storm that is expected to move into the Bering Sea on Wedshday afternoon into Thursday. This storm will bring an elevated risk of coastal flooding from the Bering Strait to Point Hope Wednesday night into Friday, with high surf possible on south and west facing shores of Norton Sound Wednesday night into Friday.
