Significant Issues:

Major Coastal Sea Storms

Overall incident operations for the 2022 September West Coast Storm (DR-4672) disaster have transitioned from response in the SEOC, to recovery coordinated through the State/FEMA Joint Field Office (JFO). Mass care operations will continue to be coordinated through the SEOC through November 11th and then transition to the JFO for long-term and occasional Mass Care support for feeding and interim housing identification.

2022 October Chukchi Sea Storm

The Northwest Arctic Borough has confirmed no disaster level damages from this storm. SEOC has remained in frequent contact with the North Slope Borough as they assess their storm damages. The Borough will decide by Friday (Oct 28) if their storm damages warrant a request for state assistance.



- Winter weather advisory in effect until 7:00PM this evening for the Municipality of Skagway.
 Additional snow accumulations up to 5 inches expected on the Klondike highway above 1500 feet including White Pass.
- High wind watch is in effect from Friday afternoon through late Friday night for the Central and Eastern Aleutians. West to Northwest winds 40 to 60 mph with gusts up to 80 mph possible.
- Special weather statement issued for strong winds and heavy rain expected for portions of Southeast Alaska through the weekend.
