Juneau Suicide Basin Flooding:

The Joint State and FEMA PDA group completed their assessments in the Juneau area on Friday and have demobilized along with the SEOC CBJ Branch Director as the disaster response transitions to recovery operations.

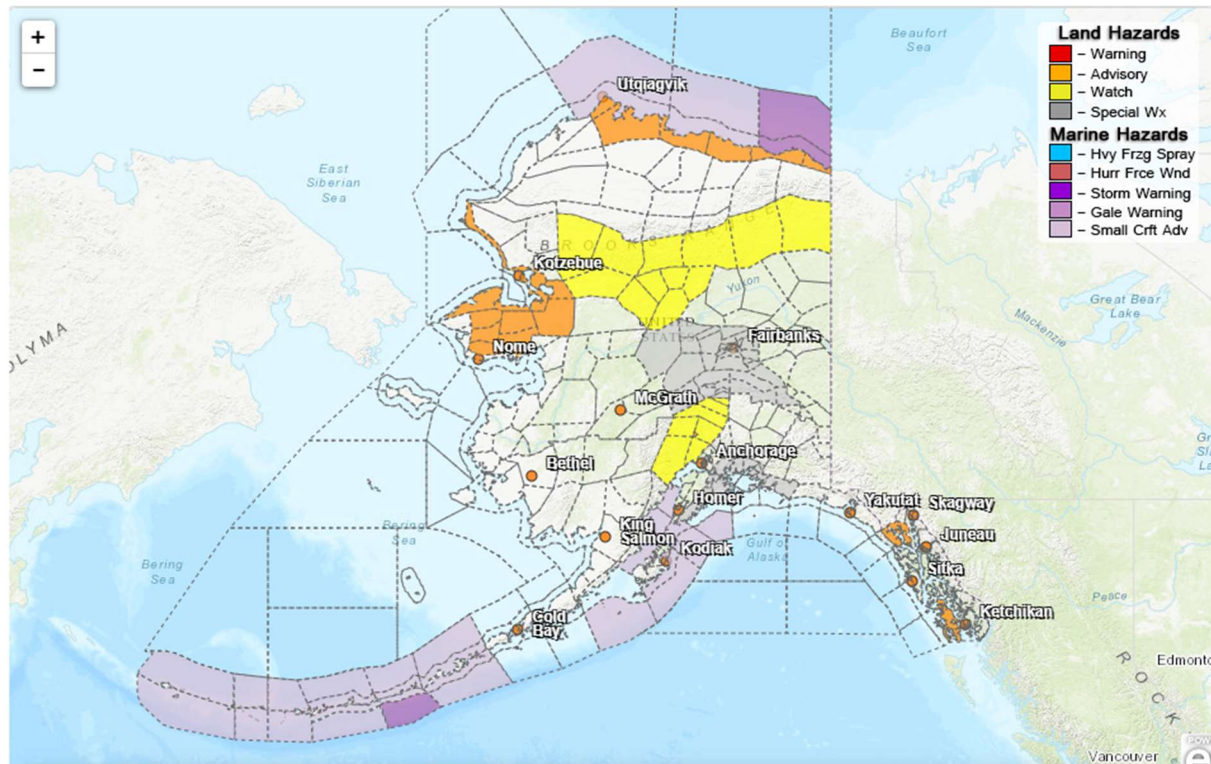

The following Warnings, Watches, and/or Advisories have been issued:

Flood Watch:

- Upper Kobuk and Noatak Valleys; Southeastern Brooks Range; Upper Koyukuk Valley – remains in effect through Tuesday afternoon.
- Susitna Valley – in effect through Wednesday morning.

Flood Advisory:

- Susitna Valley – in effect until 10 AM AKDT Monday.

High Surf Advisory:

- Baldwin Peninsula and Selawik Valley; Chukchi Sea Coast; Northern and Interior Seward Peninsula – in effect until 10 AM AKDT this morning.
- Northern Arctic Coast – in effect until Noon AKDT today.
- Central Beaufort Sea Coast – in effect until 6 PM AKDT this evening.
- Eastern Beaufort Sea Coast – in effect until Midnight AKDT tonight.

Special Weather Statement:

- Central Interior; Middle Tanana Valley; Deltana and Tanana Flats; Denali; Eastern Alaska Range – High water on the Nenana the Delta and the Tanana Rivers this week.
- Prince William Sound and the Eastern Kenai Peninsula – Persistent rain will cause stream and river rises through Wednesday.
