

Significant Issues:

SEOC and National Weather Service River Forecast Office (NWS RFC) held calls for the Yukon and Kuskowim River communities this week. These calls allow an opportunity for communities along the river to provide on the ground ice and snow measurements and firsthand current conditions in each community. A tentative launch date of Monday May 8 is currently scheduled to the hub communities of Bethel and Fairbanks to being river watch flights. Avalanche Forecast:



- Valdez Moderate avalanche advisory below 3,000ft and considerable level above 3,000ft
- Haines Considerable advisory level between 1,500 and 2,500ft, Moderate advisory level below 1,500ft and above 2,500ft
- Cordova area Moderate advisory level above 1,000 ft, low advisory level below 1,000 ft.
- Turnagain Pass: Moderate advisory level below 2,500ft and considerable advisory level above 2,500ft.
- Hatcher Pass Forecast season has finished but the avalanche threat remains.
