**Significant Issues:**

**Kodiak Mudslide**

SEOC was notified yesterday of a small mudslide in Kodiak that impacted one home. SEOC contacted the Kodiak EOC, and the Kodiak Fire Chief who stated they believe the home is stable but is under further evaluation by local engineers. The residents of the home have chosen to self-evacuate and are staying with friends or family within in the community and have not expressed a need for assistance.

The Kodiak City Manager, Borough Manager, Kodiak Fire Chief and the Public Works department continue to monitor conditions while city public works staff work on clearing drainage ditches and diverting water away from the impacted home.

SEOC also contacted DOT and DGGS to ensure they were aware of the situation should there be a request for drone and or slope stability assessments, no request for this resource has been made.

No injuries or other damages have been reported at this time.

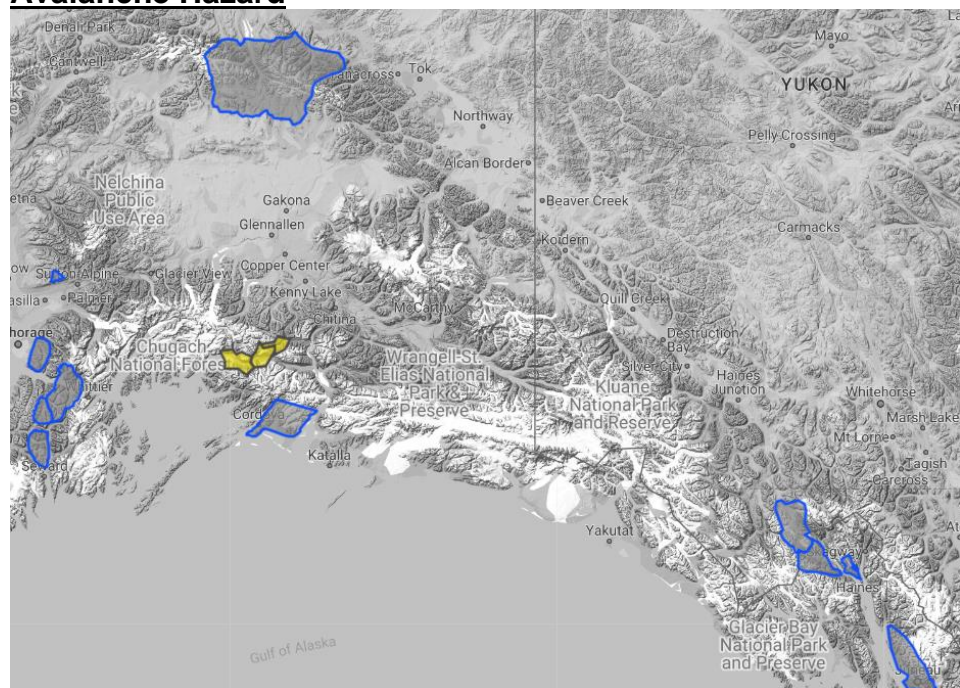

**Travel in avalanche terrain is not recommended. Avoid being on or beneath all steep slopes.**

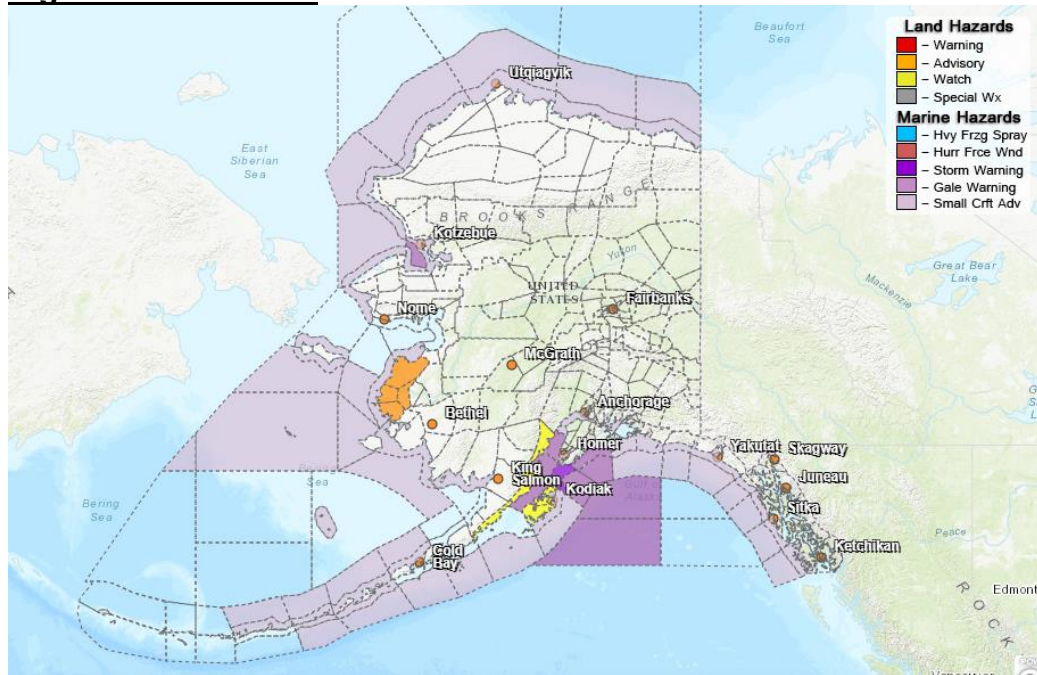
**Turnagain Pass-** Considerable above 1000' and Moderate below 1000'

**Cordova –** Advisory levels are Considerable above 2,000ft, Moderate from 1000' to 2000' and Low below 1000'
