
Cook Inlet Earthquake (FEMA Declaration 4413-DR)

The SEOC remains activated to Level 3. FEMA command and general staff will operate out of the SEOC until a Joint Field Office (JFO) can be set up. FEMA disaster survivor assistance (DSA) teams continue to work with local government officials in all three affected jurisdictions. FEMA has opened a Disaster Recovery Centers (DRC) in Wasilla, Eagle River, at the Spenard Recreation Center, and University Mall on Old Seward Highway. DRCs are locations where survivors can register with FEMA or the Small Business Administration (SBA), check their application status, receive mitigation information, and access agencies that can help with unmet needs. In addition, there is a SBA Business Recovery Center open in Eagle River and FEMA Disaster Survivor Assistance teams working in South Anchorage, Willow, and the Kenai Peninsula Borough, providing survivors registration assistance and application status checks. To date, SBA has approved 5 business loans for \$568,000. The deadline to apply for State Individual Assistance is this Thursday February 28, 2019.

Significant Weather



There is a Winter Storm Warning for the Northern and Interior Seward Peninsula, now in effect until 6 am akst Thursday, and a Winter Storm Watch for the St Lawrence Island and Bering Strait Coast in effect from Wednesday morning through Thursday.

The Yukon Delta has a Winter Weather Advisory now in effect until 6 am akst Thursday.

<u>Special Weather Statement:</u> A strong Bering Sea storm is expected to bring elevated water levels later this week.

A low pressure system will bring southerly winds to the west coast Wednesday through Friday. This will bring sea level rises and potentially some coastal flooding late Wednesday night through early Friday morning from the Yukon Delta north to Point Hope.

Confidence remains high that water levels will rise along the west coast later this week. Confidence remains low on the timing of the highest water and the locations with the highest impact along the coast.
