

High Water and Erosion Issues on the Koyukuk River

SEOC continues to monitor reports of high water, minor flooding, and/or erosion in the following communities: Akiak, Allakaket, Bettles, Hughes, and Huslia. SEOC continues to be in contact with these communities or their regional tribal organization and the National Weather Service to assess any immediate needs. Communities have taken preparedness actions, including moving property to high ground and disconnecting utilities, to reduce loss.

Tuluksak Power Outage

The SEOC is monitoring a community power outage in Tuluksak that occurred Friday afternoon on May 24. Over the weekend, the Alaska Energy Authority (AEA) worked the local utility staff to access the problem and attempt to restore service. AEA air freighted a new replacement battery but it could not be delivered due to haz mat shipping restrictions. The AEA technician will attempt to visit the community this week. The school has an operable standby generator. The terrestrial based phones are down. Tuesday, power was briefly restored, but went out again this afternoon.

Kwethluk River Erosion

The SEOC and DEC each received a faxed letter from the City and Organized Village or Kwethluk (known as the Kwethluk Joint Group) regarding a threatened home endangered by river erosion. KJC have declared a state of emergency for this erosion. City staff are placing sand bags in front of the threatened house to try to keep the building from being lost to the river.

Cook Inlet M7.1 Earthquake (FEMA Declaration 4413-DR)

DHS&EM, FEMA, and other federal agencies are managing the recovery efforts associated with the Cook Inlet M7.1 earthquake at the Joint Field Office (JFO) in Anchorage.


