## West Coast Storm

The SEOC continues to reach out to communities along the West Coast of Alaska following the strong sea storm last weekend. The SEOC is evaluating new reports and photographs showing accelerated erosion in Emmonak and Golovin. The single flooded home in Stebbins has been referred to the Red Cross and Alaska Volunteers Active in Disaster. The SEOC has not received any reports of widespread or significant damage to homes or infrastructure, or community requests for state assistance, at this time.

## **Statewide Fires:**

The SEOC has returned to Level 1 – Routine Operations, with the decline in fire resource requests and reduction in Alaska's fire Planning level to 2.

## 2019 Fire Season

The Alaska Interagency Coordination Center, (AICC) is at Preparedness Level 2.

Wildland fire totals for 2019:

- Total Fires = 615
- Total Acres = 2,433,335.1. There are currently 238 active fires with 9 fires currently staffed.

## Significant Weather:



There is a flood watch for the high flood potential in the Alaska Range from Denali Park to Rainy Pass through this afternoon. The NWS has also a special weather statement for high water on Interior Rivers and Streams this week. The Alaska State Troopers report the water level in the Nenana River at the port in town is now at bankfull; however, there are no reports of flooding in Nenana. There are dense fog advisories until 9 AM today for Gustavus, Elfin Cove, and the Southern Inner Channels including Ketchikan and Metlakatla; and until 11 AM today for the Middle Tanana Valley.
