#### **Significant Issues:**

#### **Wildland Fires**

SEOC continued support for wildland fire operations today.

The community of Cooper Landing, in the Kenai Peninsula Borough has been reduced to a "Ready" status as of this morning, because of fire activity on the Swan Lake Fire. SEOC continues to support the Borough and Swan Lake Fire operations.

SEOC continues operations to implement State Public Assistance, Individual Assistance (IA), and Temporary Housing pursuant to Governor Dunleavy's State Disaster Declaration for the Matanuska Susitna Borough and Kenai Peninsula Borough.

Volunteer, faith-based, and other Mass Care agencies are engaged in supporting survivors with emergency supplies and relief actions

The Alaska National Guard and Alaska State Defense Force are continuing to coordinate with SEOC to support operations at the swan lake fire.

#### **Water Shortages**

Rain forecasted from this weekend should have provide some relief to the communities affected by drought. SEOC continues to work with the Lake and Peninsula Borough, Kenai Peninsula Borough (KPB), City of Cordova, and Alaska Department of Environmental Conservation and regional tribal health organizations to support the following communities that have reported water shortages:

- Chignik Lagoon Lake and Peninsula Borough declared a disaster August 22 for this incident. Faith-based volunteer agency, Samaritan's Purse, delivered 480 gallons of drinking water to the community on Tuesday.
- Seldovia
- Chignik Lake
- Tatitlek community reported a crew was able to repair their water transmission line and increase their reservoir depth so that they are now able to maintain 20-22 ft of water storage.

- Nanwalek the KPB declared a disaster August 29 for this event.
- Cordova the KPB declared a disaster August 29 for this event.

### 2019 Fire Season


The Alaska Interagency Coordination Center, (AICC) is at Preparedness Level 3.

Parks Highway: Stop and Go traffic is expected from mile post 76 to mile post 99. Expect delays due to emergency vehicles on the road.

Sterling Highway/Seward Highway junction to milepost 71: Travel is not advised due to poor air quality. Pilot car operation are in effect but status can change, no stopping along the roadway. Watch for firefighting personnel in the area.
