#### **Significant Issues:**

#### Wildland Fires

Application for State Disaster Individual Assistance remains available online through October 22, 2019.

#### **Water Shortages**

Due to the recent rainfall across much of the state including the Lakes and Peninsula Borough and Kenai Borough regions the water shortages of fresh water have begun to subside. The SEOC will continue to monitor conditions in the communities that have reported shortages to our office. The SEOC will also continue to coordinate with the Alaska Department of Environmental Conservation, regional tribal health organizations and other state and local agencies for future long term solutions or improvements for these communities.

# 2019 Fire Season

The Alaska Interagency Coordination Center is at Preparedness Level 2.

Wildland fire totals for 2019:

- Total Fires = 721
- Total Acres = 2,585,644.8 There are currently 163 active fires with 3 fires currently staffed.


