NTAS BULLETIN On January 4, 2020, Acting Secretary of Homeland Security Chad F. Wolf issued a new National Terrorism Advisory System (NTAS) Bulletin pertaining to the changing threat landscape following the successful U.S.-led airstrike in Iraq that eliminated Qaseem Soleimani, the head of the Iranian Revolutionary Guard Corps-Quds Force, a U.S.-designated Foreign Terrorist Organization.

Significant Weather:



A winter weather advisory is in effect for the Juneau Borough and Northern Admiralty Island, Haines Borough and Lynn Canal.

A winter storm watch is in effect for the Taiya Inlet and Klondike Highway, and the Haines Borough and Lynn Canal.

A special weather statement is in effect regarding another round of cold temperatures for the Central Interior, Deltana and Tanana Flats, Eastern Alaska Range, Middle Tanana Valley, Southeastern Brooks Range, Upper Koyukuk Valley, Upper Tanana Valley and the Fortymile Country, and the Yukon Flats and Surrounding Uplands. Temperatures along the AlCan Border are expected to fall to around 50 below, while temperatures in the Middle Tanana Valley will fall into the 30s below Sunday and Monday before starting to warm. High temperatures will only be 5 to 10 degrees warmer than the lows. Residents should prepare for the cold, especially if traveling, by keeping cold weather gear available at all times.
