

Blizzard Warnings are in effect for Thompson Pass, Skagway, and the Klondike Highway until 6 PM today.

A High Wind Warning is in effect until 6 AM tomorrow for the Juneau area.

A High Wind Warning is in effect until 6 PM today for the Valdez area.

Winter Weather Advisories for blowing snow are in effect for the Western Arctic Coast, Chukchi Sea Coast, Bering Strait Coast, and Saint Lawrence Island until tomorrow morning.

Wind Chill Advisories are in effect until midnight for the northern Susitna Valley and eastern Alaska Range.
