

Riverwatch 2020



The pre-deployment phase of Riverwatch has begun. The National Weather Service is holding twice-weekly teleconferences with communities on the Yukon, Koyukuk, and Kuskokwim Rivers to discuss breakup progression and potential flood threats.



Significant Weather:



A flood watch is in effect until 1:30 PM today for an ice jam on the Chena River just downstream from Milepost 26 on Chena Hot Springs Road near the confluence with Hunts Creek.

A special weather statement is in effect for localized minor flooding across the interior. Rapid snow melt over the past several days is causing minor flooding of numerous low-lying areas across Interior Alaska. Some locations with full culverts and ditches are backing up water and causing flooding in low lying areas, including on some roads and driveways. Many sloughs and rivers have water running on top of the ice as well. Areas that currently have minor flooding will likely have water remain for the next few days until drainage ditches and culverts clear. Cooler night time temperatures from tonight through next week across the Interior will slow down the snow melt, and lessen the flow of water into these low lying locations over the next several days.
