Coronavirus (COVID-19) Pandemic

A unified command has been established at the SEOC. The SEOC Preparedness Level remains at Level 3 for this event.

2020 Fire Season

The Alaska Interagency Coordination Center, (AICC) is at Preparedness Level 1.

Wildland fire totals for 2020:

Total Fires = 309

Total Acres = 178,504

There are currently 54 active fires with 0 fires currently staffed.



Significant Weather:




Special weather statement for high water on the Matanuska River. Persistent rainfall from a slow moving low pressure system is expected to cause water levels to rise on the Matanuska River with water levels expected to crest on Thursday morning.

Special weather statement for heavy showers in the Eastern Interior. Showers are expected to spread east across the interior with one quarter to three quarters of an inch of rain near Fairbanks. Over one inch of rain is expected over the Alaska Range and the Tanana Yukon uplands. Showers are expected to taper off this evening.
