Significant Issues

Chignik 7.8 Earthquake

The State Emergency Operations Center (SEOC) received a local declaration with request for state assistance from the City of Sand Point due to the Magnitude 7.8 earthquake on July 21, 2020. The declaration describes damage to city-owned waterfront infrastructure including roads, buildings and docks.

Coronavirus (COVID-19) Pandemic

A unified command has been established at the SEOC. The SEOC Preparedness Level remains at Level 3 for this event.

2020 Fire Season

The Alaska Interagency Coordination Center, (AICC) is at Preparedness Level 1.

Wildland fire totals for 2020:

Total Fires = 329

Total Acres = 181,208

There are currently 24 active fires with 1 fire currently staffed.


