THREAT LEVEL CHANGES:

Significant Issues:

2020 December Southeast Storm Disaster:

SEOC remains at Level 3 and is actively engaged in response operations to Southeast Alaska communities impacted by the recent storm. Weather continues to challenge some response operations and there is risk of additional landslides.

Multiple state, federal, local, tribal, and non-profit agencies are engaged in the response in conjunction with Governor Dunleavy's declaration of disaster for the Southeast Alaska region.

Haines:

SEOC Haines Division Supervisor on scene coordination of the state response in conjunction with Haines Emergency Operations Center (EOC). United States Coast Guard is supporting Haines EOC with several Incident Management Team positions and an Incident Action Planning cycle has been established.

The Haines Borough Assembly approved the Mayor's local declaration of disaster for thirty days in an Assembly meeting last night.

Alaska State Troopers (AST) is working to supplement the normal Trooper presence in Haines to assist with operational coordination and in support of the Haines police department.

Deployed State Division of Geological and Geophysical Survey geologists and National Weather Service Incident Meteorologists, using airborne reconnaissance and ground based surveys, have provided Haines EOC with some initial risk assessments for additional slides and weather forecasts. Based upon these reports, some evacuations have been lifted. However, areas south of the major slide on Beach Road continue to be evacuated due to slope instability. Some road repair work was also delayed due to landslide risk. Additional geologic assessments are ongoing to provide recommendations on when evacuations can be lifted and areas reopened.

Multi-agency Mass Care operations continue in Haines due to ongoing evacuations and residential damages. Approximately 95 people were in non-congregate shelters overnight, with an additional 100 or more evacuees sheltered in housing provided by family or neighbors. Operations continue with counseling, food, and emergency supplies for survivors. Additional, contingency congregate shelters at the high school and local churches are ready should they be needed.

Road clearing, infrastructure repair, debris management, and damage assessment operations continue.

Other Southeast Alaska Communities:

In addition to Haines, SEOC is in contact with multiple Southeast communities reporting storm damage. SEOC is coordinating resources requests and technical assistance for these communities including geologic, dam, and disaster process information. SEOC continues to receive additional damage reports and refine initial assessments. Yesterday, SEOC received initial damage report updates from Tenakee Springs, Gustavus, and Wrangell.

Coronavirus (COVID-19) Pandemic:

A unified command has been established at the SEOC. The SEOC continues to support statewide response to COVID-19.

State of Alaska Department of Health and Social Services (DHSS)

DHSS is operating as the Medical Branch under the State EOC/Unified Command.

Significant Weather:



A Special Weather Statement is in effect until 7:00 P.M. today for the Western Prince William Sound. Heavy snow is possible along the Seward Highway from Moose Pass to Seward through this evening. Up to one foot of snow accumulation is possible across the area.

A Special Weather Statement is in effect until 3:00 P.M. today for the Haines Borough and Lynn Canal. The Flash Flood Watch has expired and precipitation is expected to be lighter and scattered as well as mixed with snow over the next several days. However, the ground remains saturated with continued runoff from the record rainfall event over the last 7 days. Many areas remain unstable. Please stay vigilant near steep terrain and monitor conditions for any changes.
