

Significant Weather:



A Wind Advisory is in effect for the Eastern Alaska Range until noon tomorrow. South winds of 25 to 40 mph with gusts to 60 mph are expected across the area.

A Winter Weather Advisory is in effect for the following areas:

- Western Arctic Coast, Chukchi Sea Coast, St. Lawrence Island & Bering Strait Coast until 6:00 A.M. Saturday. Winds gusting as high as 50 mph will cause areas of blowing and drifting snow.
- Yukon Flats and Central Interior Region until 6:00 P.M. today. Winds gusting as high as 40 mph will cause areas of blowing and drifting snow along summits on the Dalton, Elliott, and Steese Highways.
- Haines Borough & Lynn Canal until 9:00 A.M. today. Total snow accumulations of 10 to 16 inches are expected. Snow is expected to change to rain later today.
- Taiya Inlet & the Klondike Highway until 9:00 A.M. today. Total snow accumulations of 6 to 10 inches with winds gusting as high as 35 mph.
- A Special Weather Statement has been issued for Kodiak Island. Strong winds with rain are expected to continue across the island throughout the day.
