Significant Issues:

Tuluksak Washeteria Fire:

On Saturday, January 16, 2021, SEOC received a report that the Washeteria in Tulukak was on fire. Subsequent reports were that the structure was a total loss. The Washeteria serves as the only public watering point for this community and supplies the school.

SEOC was in contact with the Alaska Department of Environmental Conservation (ADEC), Yukon Kuskokwim Health Corporation (YKHC), the Tulusak Tribal President, and the State Fire Marshal. Over the weekend and yesterday, YKHC and ADEC Remote Maintenance Workers were providing assistance, attempting to use the remaining water well and piping to supply the community's school. Early response operations were complicated by blizzard conditions in the area.

SEOC remains in active contact with the community and responding agencies to coordinate response assistance and recovery.

Coronavirus (COVID-19) Pandemic:

A unified command has been established at the SEOC. The SEOC continues to support statewide response to COVID-19.

State of Alaska Department of Health and Social Services (DHSS)

DHSS is operating as the Medical Branch under the State EOC/Unified Command.



Significant Weather:



A Special Weather Statement is in effect for much of the Central Interior Region. Light snow and gusty winds are expected throughout the region. Snowfall totals of up to 1 inch are expected in the Fairbanks bowl and areas south, with 1-3 inches possible north and east of Fairbanks, through today.

A Winter Storm Watch is in effect for the following areas:

- Yukon Delta until 3:00 P.M. Thursday. Heavy blowing snow possible, with total accumulations of up to 2 inches. Winds gusting as high as 55 mph will cause near blizzard conditions.
- Eastern Norton Sound & Nulato Hills until 9:00 P.M. Thursday. Heavy blowing snow possible with total accumulations of up to 2 inches, and localized amounts up to 5 inches, are possible with winds gusting to 45 mph.
- St. Lawrence Island & Bering Strait Coast until 6:00 A.M. Saturday. Heavy blowing snow possible with total snow accumulations of 4 to 7 inches, and localized amounts up to 14 inches, are possible. .Winds gusting as high as 55 mph will cause near-blizzard conditions
- Southern Seward Peninsula Coast until 6:00 A.M. Saturday. Heavy snow blowing snow possible with total snow accumulations of 7 to 11 inches, and localized amounts up to 16 inches, are possible. Winds gusting as high as 50 mph will cause near-blizzard conditions.

A Winter Weather Advisory is in effect for the following areas:

 Baldwin Peninsula & Selawik Valley until noon today. Snow accumulations of up to 1 inch are expected. Winds gusting as high as 35 mph will cause areas of blowing and drifting snow reducing visibility. Eastern Alaska Range, Middle Yukon, & Lower Koyukuk Valleys until 3:00 P.M. today. Additional snow accumulations of 1 to 2 inches, with localized amounts up to 4 inches, are expected. Winds gusting as high as 45 mph will cause areas of blowing and drifting snow.
