

A Winter Weather Advisory is in effect for the following areas:

- Chukchi Sea Coast, St. Lawrence Island & the Bering Strait Coast until 6:00 A.M.
 Saturday. Winds gusting to 45 mph will cause areas of blowing and drifting snow. Wind chills to 40° below are expected today.
- Northeast Gulf Coast, including Yakutat until 9:00 A.M. today. Total snow accumulations
 of up to 8 inches are expected.

A Wind Chill Advisory is in effect for the Central Beaufort Sea Coast & Western Arctic Coast until noon today. Wind chills of up to 50° below zero are expected.
